## SERIOUS SITUATION.

### Paris Excited Over the Actions of the Military Governor.

### Coal Miners Winning Strikes Over the Mine Operators.

### Col. Bryan, of the Third Nebraska Regiment, Visits Washington.

### YELLOW FEVER IN THE SOUTH.

Paris, Sept. 22.—The situation here is generally admitted to be grave by both the press and people. The conflict between the civil and military authorities is becoming acute. The sudden and unexpected arrest of General Serbelloni, military governor of Paris in the charge of forgery and using forged documents, assumes a grave aspect on account of the circumstances attending this intervention of military authorities in the civil court. At the present moment, when the political atmosphere is surcharged with dangerous electricity, generated by the Dreyfus affair, the general who has just quitted the cabinet in defiance of civil authority takes, without consulting his successor or premier, an important step. In ordinary circumstances, the military governor is empowered to act independently; but now that the Dreyfus question has become a great national matter, every proceeding in the affair has state importance. Gen. Serbelloni's ignoring of this obvious fact is very significant. He comes forward as the defender of the army, prosecutor of the supposed assassins and to regulate revision of the case. From this to appeal to the public in the line of the establishment of a dictatorship there is no wide step.

The French asserts that Premier Brisson disavows the measures taken against Fiquier, which he says were instigated without knowledge of the cabinet.

### MINERS WINNING.

### The Coal Miners Are Gaining Victories Over the Operators.

Monongahela City, Pa., Sept. 22.—Having secured a victory the third pool of miners will now turn their attention to mines of the fourth pool, where the Chicago agreement is being violated. The contest will be opened in a few days and the officials say that it will be waged vigorously until every operator is paying the district rate. Three mines in the third pool are still idle, the employer, Captain S. S. Brown, not having signed a willingness to comply with the Chicago agreement. The fight will be continued at those mines until the strikers are successful.

Yellow Fever in Mexico. Merida, Mexico, Sept. 22.—There have been no more deaths from yellow fever in the interior towns, but mainly of intermittent fever, which at first developed the doctors.

### COL. BRYAN.

### The Dress Parade Soldier of Nebraska Is at Washington.

Washington, Sept. 22.—Col. William J. Bryan, Third Nebraska volunteers, was at the war department today and occasioned much interest among the employees as a returned soldier hero. Col. Bryan was accompanied by Gov. Holcomb and Representative Stark, of Nebraska. Neither to the acting secretary of war nor to the adjutant-general did Col. Bryan or Gov. Holcomb make any request as to the mustering out of the Third Nebraska regiment, or allude to the desire of Col. Bryan in reference to the subject.

After leaving the war department Col. Bryan and party went to the white house, where they were cordially received by President McKinley and remained in conference for more than an hour. They did not prefer a request for the mustering out of the regiment as a whole, but for the discharge of such members as are disabled by disease or have peculiar calls upon them. They represented about twenty-two per cent of the members of the regiment are ill, and urged that these should be relieved. The president made no positive promise. Bryan said as he left the white house that he would return to his regiment tonight.

### Aguinaldo Sends Representatives With Instructions.

### Death of the Emperor of China Reported at Peking.

### Several Hundred Spanish Troops in Porto Rico Embark for Spain.

### REPUBLICAN CONVENTION IN NEW JERSEY.

San Francisco, Sept. 22.—The steamer China from Hong Kong and Nagasaki is in harbor. The China shows a bill of health and was not put in quarantine. General Merritt did not come on the China as was expected, but Brigadier General Greene and staff are on board with 150 soldiers returned from Manila on account of sickness.

Among the passengers of the China were seven recruits, who came back because of the expiration of their terms of service. Other passengers were Philip Agonito and Jose Lopez, who are going to Washington as representatives of Aguinaldo. Agonito declines to make public what Aguinaldo wants or expects, but states that the insurgents generally look for ultimate independence.

General Greene says he received orders to proceed to Paris by the way of Suez with reference to the report that he was recalled owing to his action in conducting an illegal court martial at sea. San Juan, Porto Rico, Sept. 22.—The Spanish transport, San Francisco, sailed for Spain Wednesday. Captain General Macias and staff reviewed the departing soldiers, who bade farewell to sweethearts and wives. Some of the soldiers wept profusely. The Spaniards, at the meetings of the military commissions, are raising many questions regarding the civil administration of the island and the disposition of the public property, but the American consuls refuse to discuss them as being beyond their jurisdiction.
