GERMANS RENEW VIOLENT ATTACK ALONG

British Warship Disabled by Forts of Dardanelles

LINE FROM FLANDERS TO SWITZERLAND

Russians Win Decided Victory Over the Austrians in Galicia by Retaking Jaroslau--Turkish Ships Batter Czar's Ports in the Black Sea

KAISER'S FORCES REINFORCED HEAVILY

ALLIES RUSH FRESH MEN TO THE FRONT TO REPEL TEUTONS' ASSAULTS

London, Nov. 16.—What now has become another well defined stage of the battle in west Flanders, that is to say, a second concerted attempt of the German army to blast its way through to the sea, was flaming and roaring from Neuport to the French frontier today without definite result so far on either side.

The area near the coast formerly held by the extreme German right and from which the invaders were forced by the allies after many days of hard fighting is held only by dead, wounded and dying, the inundation having made the vicinity uninhabitable for the living and having prevented an advance of the British, French and Belgian allies.

Many Left to Perish

Hundreds of Germans left behind in the retreat doubtless will perish. Thousands more on both sides are yet to perish in the struggle now progressing, the outcome of which will decide whether the Germans are going to reach the French coast this winter.

German Courage Praised

An official dispatch from the British army headquarters at the front today pays a tribute to the way the invaders are meeting with death, and speculates, as heretofore, whether this is due to patriotism or to ironclad discipline. Whatever the explanation, Colonel E. D. Swinton of the British army intelligence department, who writes these eyewitness accounts, says:

"The German troops have won our respect for the day in which they have advanced."

Only a vague picture can be formed up to the present as to what is happening on the Russo-Turkish frontier or in Egypt. Experience has shown that both sides will for days claim the first victory as their respective troops clash near the borders. Through German sources emanate the report that the Turks have bombarded "successfully" the Russian fortified seaports of Batum on the Black sea.

Information with regard to what is occurring at the Dardanelles was confined today to Turkish claims, which contend that a British warship was struck by a shell, which caused an explosion aboard. No advice have been received from the east to contradict the news of a consistent Russian advance along virtually the whole battlefront.

No Change, Says Paris

Paris, Nov. 6.—The French official announcement given out in Paris this afternoon says yesterday passed without any perceptible modification on the front. The fighting between Dix-

TODAY'S DEVELOPMENTS

Germany is striking another mighty blow along the whole line of battle. Recrudescence of activity is indicated by today's official French statement, which mentioned severe encounters at various points between Flanders and the Swiss border.

Meanwhile fighting is proceeding actively by land and sea in the new war zone created by Turkey's entrance into the conflict, and a British warship is said to have met with disaster in attack on the Dardanelles. The battle in Belgium has resulted in no decisive settlement. The fiercest encounters center about a sharp bend in the German line forming a triangle with the northern base at Dixmude, the southern at Ypres and the apex about Roulers.

About the small area compressed great bodies of men, engaged in so deadly a struggle that, heedless of the violence of artillery fire, the opposing forces have pushed forward until they have come into actual physical contact. Only sheer weight of men and metal is sufficient to win a temporary advance. The plains of Flanders thus have been transformed into something like a gigantic football field.

Reports from British and French sources make the claim that the German attack is weakening and that the allies now have a reasonable hope of driving back their foes to the interior of Belgium and thus compelling a general retreat along the rest of the line.

German advances, however, offer no basis for such a conclusion. Apparently the Germans are bringing in heavy reinforcements in the direction of Arras instead of diminishing the fury of their attacks. Emperor William is said to be on the scene, personally directing the attack. Forty heavy German guns from the Krupp works at Essen are on their way to Arras, at which point the attack is developing with violence, in pursuance of the supposed new plan of the Germans to pierce the French line at that point.

Along the rest of the line the offensive generally remains with the Germans. The French statement says that in the region of the Argonne forest in the Woivre district and further east, around Nancy, there have been heavy engagements, in some instances leading to bayonet encounters.

No important victories are claimed by the French, although minor advances are said to have been maintained at various points.

In the east the Russians claim a victory over the Austrians. They have reached the town of Jaroslau near the long disputed fortress of Przemysl. Petrograd reports its troops have taken about 5,000 Austrian prisoners.

In Poland the Germans have employed the same tactics as in France by pushing forward their troops as rapidly as possible, and meanwhile fortifying a strong line to the rear, to which they might fall back. They have given way to these selected positions and the Russians now face the same problem which confronted the French and British in France of driving out the enemy from strongly fortified positions. For that reason it is expected that some time will elapse before the issues in the east are decided definitely.

Russia is prosecuting vigorously the war against Turkey. Petrograd advices are that Russian forces have entered Armenia by two routes and that several Turkish regiments have been captured. The Russian government asserts that it has sufficient forces independent of those engaged with the Austrians and Germans to cope with the Turks, so that, for the present, at least, Turkey's activities are not expected to affect materially the fighting in other fields.

The Turkish fleet continued its activities in the Black sea, having bombarded the fortified Russian seaport of Batum.

No information has been received of the fate of the British warships reported to have been damaged in the bombardment of the Dardanelles.

A British steamer is said to have been sunk off Alvali, Asia Minor, and two British vessels are reported to have been seized by the Turks at Smyrna.

The British and Japanese forces attacking Tsing Tau are continuing their efforts, according to official announcement in Tokio, toward the capture of outlying German forts, which must be taken before the attack on the main position is inaugurated. More than 1,000 Japanese have been killed or wounded.

Petrograd reports that Count von Schwerin is dead of wounds received in fighting in the east.

Russia's long cherished hope of extending the sphere of Slavonic control to the Dardanelles has revived with fresh vigor as a result of Turkey's participation in the war. In the Russian press the name of Constantinople has been replaced with the old Slavonic name of Tzargard.

MUSSULMEN JOIN TO DEFEND FAITH

TURKS EXCITE RELIGIOUS FERVOR OF THOSE WHOSE HELP THEY NEED

San Francisco, Nov. 6.—Private advices today to prominent British shipping agents here from their corporations in Valparaiso report that an engagement is now taking place off Yauco, Peru, between British, German and Japanese warships. Dispatches telling of a previous British-German naval engagement are confirmed in the message.

Dover, England, Nov. 6 (Via London).—Heavy firing was heard off Dover this morning. It could not be ascertained whether artillery exchanges were on the Belgian coast or indicated a naval engagement in the North Sea.

London, Nov. 6.—The Exchange Telegraph company has given out a dispatch from its Liverpool correspondent saying that the Turks have seized the British steamers Assolut and City of Khiri at Smyrna.

Constantinople, Nov. 6 (Via Sofia and London).—According to a Turkish official announcement, one of the British warships bombarding the Dardanelles was struck by a shot from one of the forts and an explosion onboard resulted. A British steamer also, it is stated, has been sunk at Aviall, Asia Minor, after the crew and cargo had been put ashore.

Amsterdam, Nov. 6 (Via London).—The Bossche Zeitung has published a dispatch from Sofia, Bulgaria, saying that Turkish cruisers have successfully bombarded the Russian fortified seaport of Batum on the east shore of the Black sea.

Petrograd, No. 6 (via London).—The Russians have recaptured the Galician town of Jaroslau and have taken 5,000 Austrian prisoners, according to a telegram received here from Lemberg. Jaroslau is 17 miles northwest of the Austrian fortress of Przemysl.

The Austrian attempts to cut off the Russian attackers, the message says, finally have broken down and the Austrians now are in retreat along the River San.

Paris, Nov. 6.—Grand Duke Nicholas, commander in chief of the Rus-

sian forces in the field, has sent a telegram to General Joffre, commander in chief of the French, saying the Russians have gained in east Prussia, the greatest victory since the beginning of the war.

Mohammedans will Join

Berlin, Nov. 6 (By Wireless).—According to information given out in official quarters today to the press, the Sheik-ul-Islam, the chief ecclesiastical dignitary of Mohammedanism in Turkey, has issued a decree in Constantinople saying that in fighting with Russia, England and France the duty of every Mussulman is to his faith. This decree has been spread throughout the Mohammedan world and announced to the pilgrims at Mecca.

British Officials Killed

A report was received here from Constantinople that the Ameer of Afghanistan has sent an army of 170,000 men with 135 guns to the Indian frontier. This news was given out in official quarters in Berlin today by the press.

The railroad from Herat to Kushk has been destroyed. A number of Indian border tribes have joined the Afghans. British officials on the border have been arrested and several of them have been killed.

Turks Advance in Sinai

An advance of Turkish troops in the Sinai peninsula, in the direction of Egypt, is reported in Berlin from Switzerland. The Turkish army operating against Egypt is said to number a quarter of a million men. This news was given officially to the press in Berlin today.

Austrians' Last Stand

Lemberg, Galicia, Nov. 6 (via Petrograd).—News was received in this city this evening of the capture by the Russians of the Galician town of Jaroslau with 5,000 prisoners. Military reports given out in Lemberg set forth that during the past few days the Austrians have been attacking furiously day and night. The artillery fire has been severe and leads to the impression that they have made their last supreme effort. Nevertheless the Russians have repulsed the enemy vigorously and have broken his desperate resistance. At the present time the Austrians are retreating along the River San. This last engagement was over an extended front and the noise of cannonading could be heard for a great distance.

Enormous forces of Austrians endeavored to prevent the Russians from crossing the San at a point near Monastyrze, but the Russians held their positions in spite of the resistance.

It is reported here that Austrian artillery has destroyed the chateau on the property of Prince Czartorski near Leszask on the San. Presumably the valuable historical library in the chateau was destroyed.

Wirballen an Obstacle

Petrograd, Nov. 6 (via London).—According to Russian information, Wirballen is the only obstacle to a general advance of the whole Russian front into east Prussia. The Germans, it is declared, soon will be forced to evacuate, being threatened by a flank movement of the Russian. The backward movement of the remainder of the German line left this point without sufficient support.

Turks Were Surprised

The Russian consul general at Constantinople, arriving at Odessa, stated that the Turkish officials were as surprised as Russia by the sudden offensive taken by the Turkish fleet in the Black sea. The consul general said:

CARRANZA FORCES DEFEATED BY VILLA

THE PROVISIONAL PRESIDENT'S TROOPS FORCED TO MAKE A RETREAT

CIVIL WAR SEEMS CERTAIN

JEALOUSY OF LEADERS APPARENTLY WILL BRING ABOUT BLOODY STRIFE

GUTIERREZ WILL COMPLY

NEWLY ELECTED OFFICIAL WILL MAKE GUARANTEES DEMANDED BY AMERICA

Washington, Nov. 6.—Conditions on the battlefield around Naco, Sonora, reported today by Brigadier General Bliss, were summarized in this statement by Secretary Garrison:

General Hill is entrenched in a semi-circle about Naco, Mex. He has about 1,800 men, well armed with plenty of ammunition, and about 100 cavalry, 14 machine guns and one small field gun. After the recent engagement, Maytorena withdrew and now has about 1,600 men at Villavieja, about 18 miles southwest on the railroad to Cananea. He also has 500 men at Cananea and 900 Yaqui Indians about seven miles north of Villavieja, but not on the railroad. He has also 250 at Sancedo, between Del Rio and Nogales.

It is rather thought that Maytorena will not attack Hill in his present position unless he can assemble larger forces than he now has, but there may be long range firing.

Villa Will Retire

General Villa has formally notified the national convention at Aguas Calientes of his willingness to resign command of his troops and retire to private life if that is necessary to bring about the elimination of General Carranza.

Villa is Praised

The convention, according to official reports received here today, received Villa's communication with a tumult of applause. No action was taken on it, pending the report of a commission which went to Puebla to notify Carranza of the selection of General Gutierrez as provisional president.

Villa's statement is in answer to the stipulations of General Carranza that with his own retirement, Villa and Zapata should be eliminated from military authority.

Reports of American Consul Silliman say resistance by Carranza of the convention's order will depend on the attitude of General Pablo Gonzales, commander of the division of the east. He is at Queretaro with several good troops and indications are that he will remain loyal to Carranza.

Carranza's visit to Obregon, commander of the division of the northwest, it is believed by officials here, may have an important bearing upon the situation, as Obregon has declared his loyalty to the convention and will endeavor to persuade Carranza not to plunge Mexico into another civil war.

Five thousand Villa troops were invited to Aguas Calientes by the convention to guard the city, according to today's dispatches, when General Gonzalez had assumed a threatening attitude at his headquarters a hundred miles south of Aguas Calientes. No fighting had taken place when the report was dispatched, both sides awaiting the outcome of the conference at Puebla.

Gutierrez will Guarantee

Gutierrez as stated to American agents that as soon as he is sworn in as provisional president he will issue a proclamation giving the guarantees desired by the United States, before withdrawing his forces from Vera Cruz. Villa has agreed to support Gutierrez in enforcing the proclamation, which Carranza declined to issue.

High officials here, however, said today that such a proclamation would not be sufficient to bring about the American evacuation while the forces of General Aguilar, who is loyal to Carranza, are in command of the state

SOLDIERS REACH PRAIRIE CREEK DISTRICT

SPECIAL GRAND JURY ALSO SITS TO HELP BRING ABOUT PEACE

TWO BUILDINGS BURNED

STRIKERS MAKE LAST FINAL EFFORT TO CAUSE TROUBLE BEFORE TROOPS ARRIVE

NO VIOLENCE IS REPORTED

SIGHT OF UNIFORMS MAKES MINING DISTRICT AGITATORS STOP OPERATIONS

Fort Smith, Ark., Nov. 5.—The arrival of federal soldiers to preserve order in the Prairie Creek mining district, the convening of the special federal grand jury and the burning of two more buildings at Hartford, marked the events today in the efforts of the judicial and military departments of the federal government to bring peace to the Hartford coal mining valley. According to telephone reports from Hartford, two stores were burned there early today, with origin of the fire unknown.

The court called special attention to the fact that there was no question of jurisdiction between the state and federal authorities; that action violating the federal statutes also violated the state laws. The soldiers' camp will be located near the Bache-Denman mining properties, about 25 miles south of Fort Smith.

Little trouble is expected now, despite the fact that several buildings have been burned in the mining region since the news spread that soldiers had been ordered into the field. These sporadic acts of violence, it is said, are merely the aftermath of hasty disorders and not the result of plans or plots of the union miners who control the entire field.

DEMOCRATS CLAIM AMENDMENTS LOST

CHAIRMAN PAXTON'S STATEMENT IS DENIED, HOWEVER, BY THE REPUBLICANS

Santa Fe, Nov. 6.—The republican headquarters claim that the three constitutional amendments voted on at the state election were carried by substantial majorities. Chairman Paxton of the democratic central committee says he made telegraphic inquiry to every county in the state and his compilation of figures shows the amendments lost.

Close Senatorial Fight

Carson, Nev., Nov. 5.—Returns from 188 precincts out of 210 in Nevada give for United States senator: Newlands, democrat, 7,797; Platt, republican, 7,655. This gives Newlands a lead of 112 votes, with approximately 350 to hear from.

A Divided Delegation

San Francisco, Nov. 6.—California's delegation in the house of representatives will consist of four progressives, three republicans, three democrats and one independent, as follows:

Progressives: Nolas, Elston, Bell, Stephens; republicans: Hayes, Curry, Kahn; democrats: Baker, Church, Ketter. Independent: Kent.

This lineup represents the regular party affiliation of the 11 successful candidates, several of whom had received more than one party nomination in the August primary election.

Nebraska Democratic

Lincoln, Neb., Nov. 6.—Official returns indicate that the Nebraska legislature in 1915 will be overwhelmingly democratic. In the senate the parties will be divided as follows: Democrats, 19; republicans, 14. In the house, democrats, 67; republicans, 33.

Besides re-electing Governor Moore, head the democratic party elected the state treasurer and one regent of the

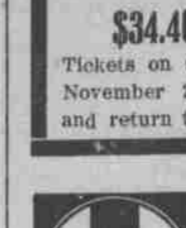

advance or retirement at any point. There was violent cannonading to the north of Arras, and also directed upon Arras, without result for the enemy.

"The German efforts in Belgium and in the north of France continue. The Germans seem to have undertaken changes in the position of their forces, which are operating in this region, and are reinforcing their reserve corps, composed of new organizations which have been severely tested, with active troops with the idea of undertaking a new offensive movement or at least to mitigate the bloody checks which have been inflicted upon them.

"Between the Somme and the Oise and between the Oise and the Meuse there have been minor actions. We have consolidated our advance on the village of Andechy, to the west of Roye. A column of German wagons has been destroyed by the fire of our artillery, at long range, in the region of Nampeol to the north of the forest of Algué.

"Near Berry-au-Bac we have retaken the village of Saigneul, which had been captured by the Germans. There has been a furious fight in the Argonne, where, as a result of fighting with the bayonet, our troops drove the Germans back.

"In the Woevre district fresh attacks by the enemy have been repulsed.

"To the northeast and to the east of the Grande Couronne of Nancy (the chain of fortified positions surrounding Nancy) in the region of the forest of Perroy, and between Baccarat and Blomont, our advance posts have been attacked by mixed detachments of the enemy, whose movements everywhere were checked.

"Russia announces officially a great Russian victory in Galicia."

The Belgian Statement

Havre, Nov. 6 (via Paris).—The Belgian official communication given out here today says:

"The enemy is showing no activity on the Yser front, but several detachments with quick firing guns still occupy the left bank of the Yser near St. George and Stuyvekenskerke.

"The Germans have placed numerous cannon, including all calibers, on the Belgian frontier between Middlekerke and Zeebrugge.

"On the Diksmuide-Blixchoote front the Anglo-French offensive movement continues. Violent German attacks in the direction of Blixchoote have been repulsed.

Between Wythebaert and Messines the offensive movement of the allies has progressed as far as the road joining these two towns."

Germans Report Successes

Berlin, Nov. 6.—News given out officially for the press today says that the hard fighting in the northwest continues, but that it is as yet without result. The Germans have, however, been able to make slow advances at several points from Ypres inland.

The clash in Poland, which has been expected for several days past, has not yet developed. One reason is that the condition of the roads makes rapid movement impossible. The cold weather is now making some improvement in this regard.

No exact information as to the positions of the Teutonic allies is available.

The Russians are unquestionably the superior force, a condition the allies are seeking to overcome by advantages in position. Farther to the south the Austrians continue to harass the enemy. No day passes, according to this information given out in Berlin, without a report of the capture of a thousand or more prisoners.

The improvement in the situation on the southwestern front is shown by orders to reopen in parts of Alsace schools which had been closed owing to the danger of invasion.

TEXAS GIVES SILVER

Galveston, Tex., Nov. 6.—The United States battleship Texas, Captain A. W. Grant commanding, arrived in port early today for a stay of five days and to receive two sets of silver, one presented by the school children of Texas the other a contribution of citizens of the state. Today is to be taken up with visits to the battleship of representatives of Governor Colquitt, army officers and city officials. The presentation will take place tomorrow afternoon.

MUST BE GIVEN A CHANCE
What Mexican Peon Can Do With Acquired Land is a Matter to Be Settled by Time.

The Mexican peon never had a chance to become a landowner, so no one can say whether or not he will become a successful small farmer. But the experiment has got to be tried. The wants of the peon are so simple that some persons believe that when he once gets his land, he will not cultivate it to the extent to which it should be cultivated. Corn and beans are chief crops. Ninety-five per cent of the total of the whole Mexican population may be said to rely on corn as the staff of life. Cultivating corn in the primitive way is a very simple matter, but it does not secure anything like the full productiveness of the land. The Mexican peon still clings to the old-fashioned wooden pronged plow, which merely scratches the surface of the soil. It requires the use of only one hand. Progressive landowners have found it extremely difficult to get peons to use a two-handed plow of the simplest pattern. Perhaps, when he has land for himself, the peon will become more progressive. Anyhow, he must be given the chance to try what he can do with the land.—Christian Herald.

MISS M'CARTY TO BE BURIED FROM CHURCH

INVESTIGATION PROVES WOMAN
WHO KILLED SELF TO HAVE
BEEN INSANE

Archbishop Jean Batiste Pitaval has given his consent to the request of friends and relatives of Miss Nellie McCarty that she be given a Catholic burial, according to an announcement by Rev. Father Rabeyrolle, pastor of the Church of the Immaculate Conception. Miss McCarty committed suicide Monday by taking carbolic acid. According to the laws of the Catholic church, no person who commits suicide may be given a Catholic burial unless it be proved that he was of unsound mind or unless he repented before his death.

By relatives, friends and acquaintances of Miss McCarty it has been stated that she had been considered of unsound mind for many years. Two physicians also stated that they had treated the woman and had come to believe that she was insane. One of these physicians is a recognized authority on insanity and the other is one of the leading doctors of Las Vegas. These statements, coupled with the fact that Miss McCarty had endeavored to live a good Christian life and had frequently received the sacrament of holy communion, led the church authorities to believe Christian charity demanded that she receive a burial with church ceremonies. Accordingly Miss McCarty's funeral will be held tomorrow morning at 3 o'clock from the Church of the Immaculate Conception.

NOTED SPEAKER COMING

Dr. Frank H. H. Roberts, president of the New Mexico Normal University, has announced that the students in attendance at the institution will have an opportunity of listening to two of the most prominent educators in the country. John McDonald, editor of the Western School Journal, located at Kansas City, and one of the wildest speakers among the ranks of the school teachers, will visit the big state institution shortly. The other speaker will be A. E. Winship, the editor of the Journal of Education. Mr. Winship will be here in December. The New Mexico Normal University will announce the actual dates and subjects of the two speakers at a later date.

ROMEROVILLE GAP WILL BE MADE 20 FEET WIDE

WORK BEING DONE BY HIGHWAY
COMMISSION WILL MAKE

At present the Romeroville gap is one of the worst places in the highway leading to the south.

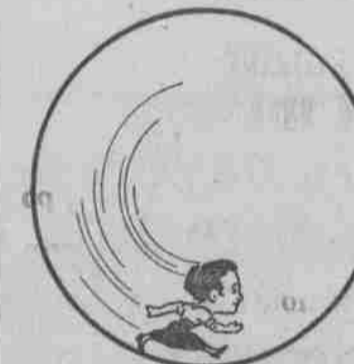
