affairs grows out of decisions of the su-
preme court, rendered since the election
was held last November, that the sub-
urban towns of Brighton Park and Cicero
were by vote of their people annexed to
Chicago. The village of Cicero, how-
ever, contested the matter and it has
since been pending in the courts. The
decision of the court annexed the ter-
ritory to the township of south and
west Chicago, but did not make it a part
of the city, the power to extend the limits
of which rests with the city council.Therein lies the trouble. The law of the
state provides whenever all of a township
lies within the limits of the city, the city
election shall be held on the first Tuesday
after the first Monday in April, and where
the township is not all included within
the city limit, the election shall be held

is fit for settlement and cultivation and
would furnish home for 5,000 settlers,
giving them 160 acres each. From present
appearances there will be five settlers
for every claim. And the rush of mer-
chants, speculators, gamblers and land
characters into the new towns will be one
of the marvels of western boom-days. At
present thousands of settlers are camped
along the borders of the promised land.
Probably at least a third of them will get
a foot-hold there and the overflow will
seek other localities in the southwest.Judge Walker thinks very many of these
settlers will drift westward into the Pan-
handle of Texas and northern New Mex-
ico. For years this greatly boomed piece
of land has stood as a bar to the advance-
ment of New Mexico and other sections
of the southwest, but now that it is to be
opened it will start the immigrants in
this direction, which will give a fresh
