WASHINGTON MATTERS.

THE COLORED MAN.

WASHINGTON, May 15.—Colored men have been complaining that their race has not been recognized in the appointments. The colored men will have no cause to complain if they are patient.

Rev. J. M. Townsend, of Indiana, appointed by the president as recorder of the general land office, is a colored man. He was a member of the 54th Massachusetts regiment, an ex-member of the Indiana legislature and was prominently mentioned in connection with the office of recorder of deeds of this district.

It is expected also that Ex-Congressman J. R. Lynch, of Mississippi, one of the ablest and most eloquent of his race, will be appointed to an important bureau office in the treasury.

PHILIP'S CHANCES GOOD. A private letter from Berlin relates that the question who is to be American minister at that court is a matter of much interest among German officials. It says: "The general belief is that when the Samoan conference has done its work one of the commissioners, William Walter Phelps, will receive the appointment as minister."

The London Times of April 27 asserted "that it is so that it is a curious fact, which I learned at the American legation, that Prince Bismarck sent the other day to the legation to make inquiries about the particulars of Mr. Phelps' public career. It looked as though the chancellor had had some private intimation that Mr. Phelps was to be made minister."

CAPITAL CHAT. Judge Matthews, who succeeded Judge Durham, as first comptroller of the treasury, and Huston, who succeeded Hyatt, as treasurer of the United States, entered upon the discharge of their new duties this morning.

Theodore Roosevelt, of New York, recently appointed civil service commissioner, took the oath of office yesterday. The board is now full. Commissioner Lyman was chosen president.

A Horrible Tale. Chicago, May 15.—The investigation of the insane asylum began in the court yesterday. The testimony showed that there were 1,000 inmates, with room for only 600, that the attendants were insufficient and food bad.

Evidence was introduced to the effect that patients were fed on pigs heads for one entire year, with potatoes for vegetables once a week. There was no service and patients foundered. The potatoes were so rotten with a result that the weak got none, and fifty of the inmates became afflicted with scurvy. One of the medical staff testified that in one ward there was an average of three in each room. It was absolutely necessary to have only one or two in some of the rooms, as the four persons were crowded into others. These rooms are 5 1/2 x 10 feet in size. The beds are 2 1/2 feet wide, but in many cases two patients are forced to sleep in them. Under such circumstances, with insufficient attention, the patients would climb over the beds and fight, and the medical attendants were frequently called six or eight times in a single night to go to patients who were attempting to commit murder or suicide.

An Heirloom in a Convert.

PHILADELPHIA, May 15.—Miss Kate Drexel, second daughter of the late Francis A. Drexel, who left \$2,000,000 to each of his three daughters, has practically renounced the world. The young lady today entered as a postulate of the order of the Sisters of Mercy in the mother house of the sisters at Pittsburgh. This is not exactly equivalent to entering the order, but those who know Miss Drexel know that this act amounts to complete renunciation of her family, of her surviving sisters and of her dear friends and of her great wealth. Miss Drexel has meditated this step for some time, through the fact has been kept very quiet.

She is well known as the most attractive of the three sisters. The youngest sister, now Mrs. E. de Murrell, who was married a few months ago, and her unmarried sister, Miss Lizzie Drexel, will sail from New York for Europe tomorrow with their uncle, A. J. Drexel.

U. S. SUPREME COURT.

The Old Clark Case—The Chinese Exclusion Act All Right.

WASHINGTON, May 15.—The supreme court has rendered an opinion in the case of Chao Chang Ping, appellant, versus the collector at the port of San Francisco. This is a suit brought to test the constitutionality of the Scott exclusion act. Shortly after the Scott exclusion act went into effect Chao Chang Ping returned to the United States from China and endeavored to secure entrance at the port of San Francisco. He left this country with a certificate entitling him to return, but the certificate was declared invalid by the Scott act. The collector refused him admittance, and suit was then brought in the United States court for the district of California to test the constitutionality of the Scott act, in accordance with the provisions of which the collector acted. The California court upheld the constitutionality of the act, and from this decision the case comes here on appeal.

This court affirms the former judgment. It holds that congress has power to abrogate the treaty, and in support of that view cites the authority of the courts on the subject, holding that the propriety of such action is no matter for judicial cognizance. Congress, it says, has power to exclude aliens from the country whose presence is deemed inimical to our interests.

The United States supreme court in an opinion by Justice Bradley awarded the executors of Myra Clark Gaines the sum of \$567,000 against the city of New Orleans for the use of the property sold by the city, but recorded by Mrs. Gaines, after long litigation. The judgment of the lower court awarding the executors \$130,000 for the use of the unimproved property was not concurred in.

Making Bets on Denver's Derby. DENVER, May 15.—The Times says: Sampson & Co. have opened a book on the Colorado Derby to be run at Overland park on Saturday, the opening day. It will be the second race, and is for 3-year-olds, only one mile and a quarter. The odds are 5 to 1 against Lady Leo, 5 to 1 against Cassandra, 10 to 1 against Master Kildare, 10 to 1 against Cocotte (imp.), even money against Receiver, 3 to 1 against Patricia, 6 to 1 against Sarah H., 4 to 1 against B. T., even money against Senator Walcott, 4 to 1 against Miss D., 4 to 1 against King Faro Second, 4 to 1 against Leadville (book full).

Pierre, Dak., May 14.—For some time hundreds of settlers have been lying in wait along the Sioux reservation for the appointment of the Sioux commission, and recently when the news was received many of them went on the reserve and staked out their prospective claims. The matter was called to the attention of the interior department officials and most of the settlers will not be molested by the government if they go on the reservation peacefully, pick out the land and make no disturbance, and it is only a question of time when the hands will be called and thrown open. In consequence of this news the last few days have developed a great rush for the best parts of the reservation. Claim shandies and improvements are beginning to speak the country across the river from Pierre, and with the news of the government's position in regard to going on the reserve, there is no telling what the next week or two will develop.

COPPER'S STATUS.

The U. S. Operators Return—Sort of an Agreement Reached up.

NEW YORK, May 15.—The steamship dock yesterday many prominent copper operators from this city and Boston were impatiently awaiting the arrival of the Cunard service for definite intelligence of the result of the European conference between American mine representatives and defunct French syndicate people. Mr. Haggis, who is sole owner of the Anaconda, looked on with keen interest when questioned about the result of his journey abroad. He said with emphasis that his journey was productive of no good.

"We were unable to come to any agreement and have come back to throw our metal on the market for what it will bring. He positively declined to say anything about the London market, who accompanied Mr. Haggis and other American mine representatives abroad, inclined to be more communicative. It is reported that Livermore said that the Americans found the Frenchmen reluctant to meet mine operators half way in settling the difficulty, was tired without foundation. The Frenchmen are not so ready and willing to enter into any agreement to prevent a panic. The French banks which held the copper, even now, have entire confidence in the metal as a security. Col. Livermore gave an outline of the terms offered by the Americans. The proposition was that the banks should take a certain number of years in which to market their copper. The number of years mentioned occasioned no dispute; that mines should reduce the production of last year, which it was deemed was far in excess of the world's wants; a certain percent until the bank's metal could be disposed of; that there should be a minimum price of about 24 1/2 per ton or an equivalent of 13 cents per pound for lake copper. It was agreed upon for the metal to be sold by the banks and mine. This figure was thought to be low enough to meet consumption and not as low as to ruin the mines. After the terms were gone over in a general way they seemed to meet the favorable view of the foreign representatives present.

The New Find mine, in the Socorro mountains, has been purchased by a Philadelphia syndicate.

A correspondent from Engle writes that the Cuchillo "gold boom" is busted for want of gold, so says a Mesilla valley paper.

Our alfalfa miners have signed an agreement creating an alfalfa trust. They propose to keep the price up if possible.—Las Cruces Republican.

Gallup note: Frank Martin was sent to the St. Vincent hospital at Santa Fe Tuesday morning. A subscription paper was circulated to raise funds with which to defray the trip expenses.

In Rio Arriba county \$7,000 in county bonds, and \$7,000 of floating indebtedness, have just been paid and canceled. At this rate of payment there will not be in three years a dollar of indebtedness on Rio Arriba county.

The success of the new smelter at Kelly has given a new impetus to mining in that vicinity. Several more mines are at work taking out ores, and several more that have been idle for some time will be worked on a lease, or will change hands.

Had it not been for their sheep flocks in the early times the poor people of New Mexico would have been perished. The wool they clipped from their native's backs brought them but little money, but the flesh of the woolly brutes kept them from hunger.

Hon. T. D. Burns was in town this week superintending the rebuilding of his telephone line from here to Tierra Amarilla. He will have an office at his store and one at warehouse here also, one at his business houses at Parkview and Tierra Amarilla.—Chama Northwest.

So far the following gentlemen are understood to be candidates for secretary of the territory: Dr. B. M. Thomas, of Santa Fe; Major J. B. Woodward, of Socorro; Hon. W. D. Kistler, of Las Vegas; Mr. D. C. Moore, of Lordsburg, and Mr. Alexander, of Hillsboro.—Enterprise.

We are in receipt of a letter from Joseph G. Parks, of Lordsburg, now in Philadelphia, which states that the report that he had withdrawn from the race for surveyor general of this territory is without foundation. He is still in the ring, and hopes to win.—Silver City Enterprise.

Building is the order of the day: from all sides and at all times throughout the day is heard the sound of the trowel, hammer and saw. Messrs. Stewart, Nabors, Mayer and Lund, have their buildings inclosed and will soon be completed. Others are progressing slowly. White Oaks is having a steady growth.—Interpreter.

Las Vegas Improvement notes: George Ward, as city marshal, has issued orders to all residents on Douglas avenue, to lay sidewalks immediately on that thoroughfare, and the extension will soon run to the bridge, thus connecting the two towns with a good foot passage.

Coors Bros. have commenced the erection of a three story rock business house in the rear of their present house on the corner of Sixth street and Lincoln avenue, which is to be 40x100 feet, and put up in a substantial manner. * * * The new sixteen room, two story house of Tom Holland, some sixteen miles out in the country, has been completed, and today all the workmen, ten in number, who have been employed in the different work, such as carpenters, painters, paper hangers and rock masons, came in. The building is said to be a handsome one, located in one of the prettiest spots in the country.

Springer's New Postmaster. G. W. Abbott, of Springer, sent a telegram to a Santa Fe man yesterday about 11 o'clock saying he had received a letter from Washington indicating that Mr. Cloutier was on the inside for the Springer postmastership. Mr. G. W. Annett has been appointed postmaster at Springer. It is a good appointment. Mr. Annett will make a first class postmaster. Mr. Valdez, the Democratic postmaster, was removed for cause. The good work should go on. The more Republican postmasters the better will the service be administered and the better will the people be satisfied.

WORK on the government industrial school has commenced. By the end of this year Santa Fe will have three Indian schools in operation, with an attendance of about 300 pupils. It is the very best location for such institutions, and in fact for all institutions of learning on account of its fine and equable climate, easy accessibility and extreme healthfulness.

COUNTY COMMISSIONER THEODORE MARTINEZ the other day at a meeting of the board stated that the county of Santa Fe had been robbed in the past few years, and that he was tired of it. Now, Mr. Martinez has been county commissioner during the past two years, as is well known. If he knows anything about the matter, the people would like to know something about it.

UNDER the act of congress approved July 30, 1886, and the recent act of the legislature providing for the refunding of certain county indebtedness, a great many of the warrants issued in this county since July 30, 1886, are absolutely and unqualifiedly illegal. We understand that legal steps will be taken in the matter to show that they were illegally issued and wholly unauthorized. There are lively times ahead.

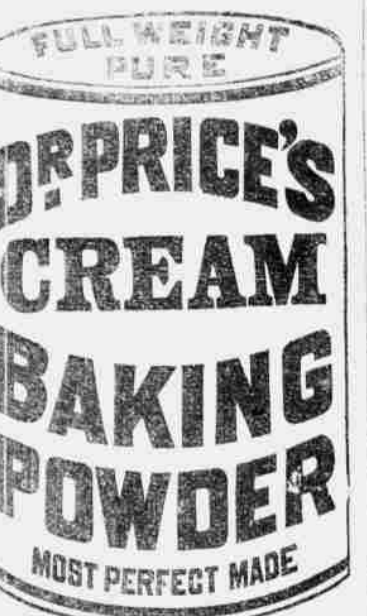

To-day there are 1,000 postoffices. The commission is better constituted by President Harrison than it was by President Cleveland, if not better than it has ever been before.

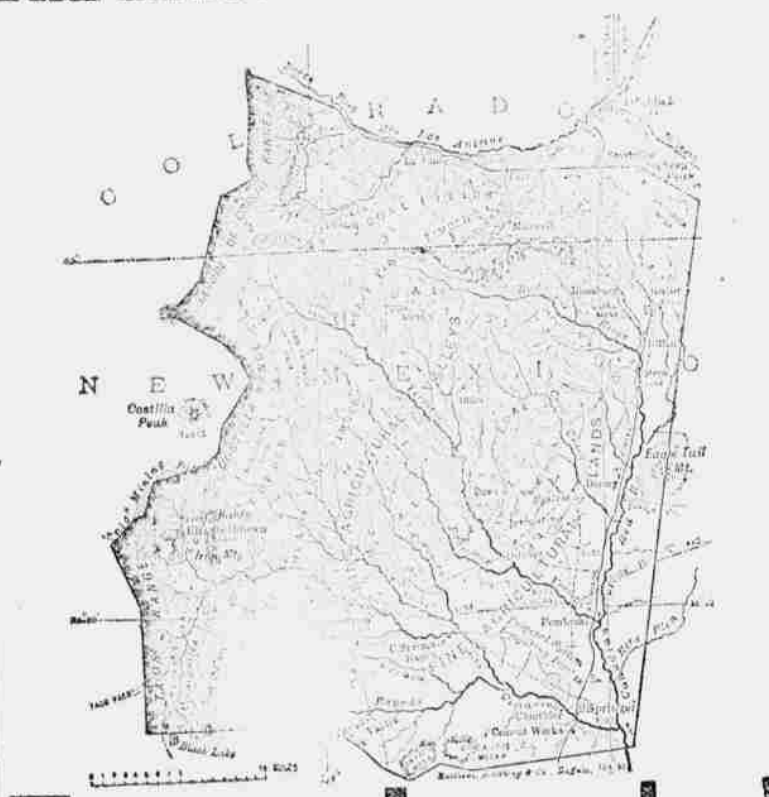

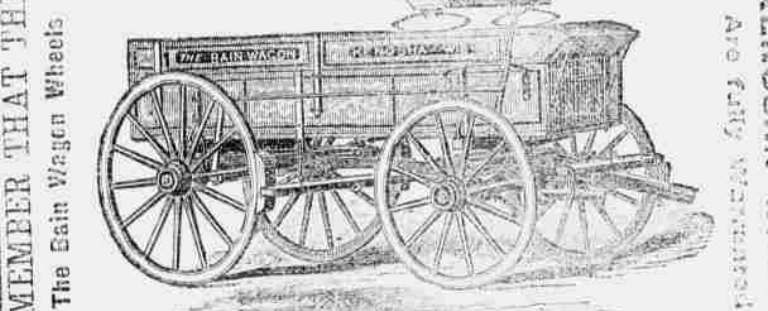

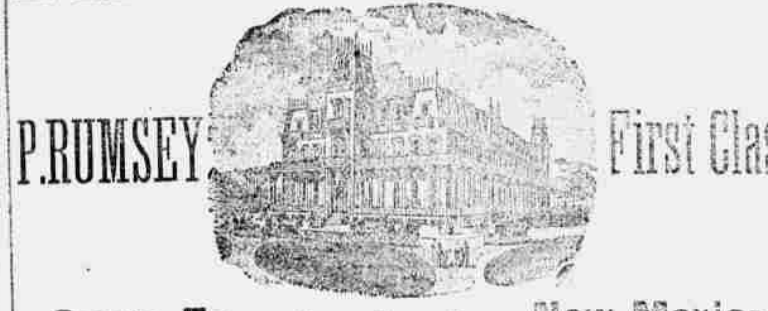

SOME NEW LAWS.

Acts of the 28th Assembly of Interest to the People.

An act authorizing and regulating

voluntary assignments for the benefit of

creditors.

Section 1.—That hereafter every volun-

tary assignment of lands, tenements,

goods, chattels, and credits, made by a

debtor to any person in trust for the

benefit of his creditors, shall be for the

benefit of all the creditors of the assignor

in proportion to their respective claims,

except as hereinafter provided; and every

assignment shall be proved or

acknowledged and recorded in the

same manner as is prescribed by

law in cases wherein real estate is con-

veyed.

Sec. 2.—It shall be the duty of the as-

signee, within ten days after the ex-

ecution and delivery of the deed of assign-

ment, to file in the district court of the

district of the county in which the

assignor, or if there be more than one,

in which any of them shall reside, unless

longer time be allowed by the judge of the

court for good cause shown, an inventory

of the property, effects and things as-

signed, and to cause the same to be

recorded in the district court.

Sec. 3.—The inventory shall be ac-

companied with an affidavit by the as-

signee, that the same is a full and com-

plete inventory of all such property,

effects and things, as far as the same has

come to his knowledge.

Sec. 4.—It shall be the duty of the dis-

trict court, or the judge thereof in vaca-

tion, in whose clerk's office such inven-

tory may be filed, to appoint two or more

disinterested and competent persons to

appraise the property, effects and things

so inventoried.

Sec. 5.—The appraisers, having first

taken an oath of affirmation before some

person having authority to administer

oaths to discharge their duties with fideli-

ty, shall forthwith proceed to make such

appraisement.

Sec. 6.—The appraisers shall file the

appraisement and their oath of office in

the office of the clerk of the district court

within five days after they shall have com-

pleted the same.
