WASHINGTON MATTERS.

WASHINGTON, July 12.—The secretary of the treasury has appointed John M. Morton, a son of the late Hon. O. P. Morton, to be shipping commissioner for the port of San Francisco.

See. Noble was slain yesterday and asked if there were any truth in the reported report that he desired to have a new commissioner of pensions in the place of Corporal Tanner. He was just getting into the department carriage at the time he was shot. He said that he had no intention of resigning. He made no answer and immediately drove off when asked if his statement could be interpreted as meaning that the publication had some foundation in fact.

TROOPS AND THE IRON BRIDGE.

Fish Commissioner Col. Marshall MacDonald and assistant, have started from Harrisburg on an extended tour west. In the party were Capt. J. W. Collins, head of the division of fisheries; Chief Clerk O'Connor, Lieut. Comr. John Brice of the navy and Mr. Bryan, clerk. Their tour will be an extended one. The most important thing they will do will be to make plans for a scheme by which the regular army is to be utilized in raising of fish.

It has been decided to establish a small fish propagation station at each army post out west and the soldiers can do what little work is necessary and guard the growing fish from depredations till they get big enough to be liberated in rivers. This is a new idea and has everybody's approval so far.

A Colorado Flood.

LAS ANIMAS, July 10.—The Arkansas river got a terrific rampage at this point yesterday. At 5 o'clock a. m., it was as low as it has been at any time this season and easily fordable. Within thirty minutes the water had risen at least eight feet, sweeping down masses of float wood, articles of household furniture, farming utensils, etc. The pile bridge just below the new iron bridge was nearly destroyed, about two-thirds of it being swept away. Although the water touched the road level, the bridge itself was not damaged. The approaches to the iron bridge not being completed all communication between the north and south sides of the river is cut off for the present, but the approaches are being pushed forward to completion. The great rise in the Arkansas was caused by heavy rains and probably a water spout on Adobe and Horse creeks, for both these streams rose with remarkable rapidity. These streams empty into the Arkansas about six miles above town. The great rise in the Arkansas canal across Adobe creek is entirely torn away, besides great damage to growing crops by the overflow of all bottom lands.

SULLIVAN IN IRONS.

The World's Champion Taken in at Nashville on Gov. Lowry's Order.

NASHVILLE, July 12.—John L. Sullivan was arrested here yesterday, upon a requisition from the governor of Mississippi.

When the Louisville & Nashville train pulled in here, a crowd gathered around the car to see John L. Sullivan. A man soon obtained circulation that a requisition was in the hands of the police, several of whom had boarded the car. After some discussion finally a struggle was seen in the car, and the officers reached Sullivan and began to drag him out. Sullivan resisted, but finally yielded to the officers. He was taken to the city hall, where he was held in custody. Sullivan's arrest was a surprise to many here. He had been in the city for some time, but had not been arrested. After a brief struggle Sullivan was taken out of the car and hustled to a carriage. In the scuffle he drew back to knock down the policeman, when Chief Clerk Clark stuck a pistol in his face and told him if he struck he (Clark) would kill him. The officers next grabbed Charley Johnson, of Brooklyn, Sullivan's backer, who resisted vigorously, but finally began to cry with pain. During all this scene Sullivan sat quietly by and was undisturbed. Clearly, Sullivan's arrest was a surprise to many here. He had been in the city for some time, but had not been arrested. He was taken to the city hall, where he was held in custody.

The arrests were made by the authority of a telegram from Gov. Lowry of Mississippi, to the Nashville chief of police. Sullivan retained ex-Attorney General Washington, who says that the officers went beyond their authority and can not hold the men. Immediate attempt will be made to get the parties out on writ of habeas corpus. Gov. Lowry's telegram awarded a reward of \$1,000. It is believed that if released Sullivan will be rearrested to secure time for the requisition to be obtained. The arrested gentlemen are now in the police station in conference with their attorney.

Jackson, July 11.—The law imposes a penalty not exceeding \$1,000 nor less than \$500 and imprisonment for twelve months, or both, for prize fighting. The party causing the death of the other is guilty of murder. Their aiders and abettors are subject to a fine of \$1,000, or jail for six months, or both.

Cincinnati, July 11.—Gov. Foraker received the following telegram to-day: Jackson, Miss., July 11.—Please direct the chief of police of Cincinnati to arrest Jake Kilrain, Charlie Mitchell and Pony Moore, and hold them until a requisition reaches you. They are charged with the crime of fighting in this state.

The matter will come up again and is regarded as specially important, as certain changes might jeopardize the president's proclamation of admission and cause it to be declared. Thus discussion as to the scope of the convention work will be very important. Much concern is felt regarding the action of the judicial appointment committee. Almost every county has aspirants for the judgeship, and there will be a strong attempt to make at least one or a dozen changes. The congressional and legislative appointment committee is likewise besieged to make districts favorable to the manifold interests of the different candidates for United States senator. Moody and Edgerton, who were elected as senators under the old constitution, are both here; the former as a visitor and the latter as the president of the convention. H. S. Peterson, of Sioux Falls, will be Edgerton's chief competitor for the senatorship. All these gentlemen will strive for such arrangement of the legislative districts as shall further their respective interests.

In some cases lead in the ore was valued at one cent per pound, and all the expenses and deductions were made from the lead contents, but as this ore is imported under the class of silver-ores, it would seem at first just that the silver should be charged with the deduction. At all events, an entirely new system is to be started and the law as it stands at least will be rigorously enforced. There are strong intimations that the department will push the matter over for congress to decide, which is more than likely if President Harrison is to call an extra session. What informed dealers believe that the enforcement of the law will keep out enough ore to carry prices materially higher, even although the ruling of weight instead of value should not be adopted.
