Masked Band Blamed  
For Raid Near Los  
Angeles

LOS ANGELES, April 24.—An  
assault over the body of M. H.  
Muller of Ingleside who was shot  
and killed by Town Marshal Frank  
Wolmer late Saturday night, while  
the marshal attempted to halt a  
raid by masked men on the Ingleside  
Home, will be held at Ingleside  
tomorrow morning. The dis-  
trict attorney announced that Wolmer  
had been slain in the course of  
his duty to protect the home and  
its inmates.

These defendants are alleged to  
be members of the Ku Klux Klan, which  
marched on Ingleside and Los  
Gardens late Saturday night, and  
engaged in pitched battle with state  
troops.

#### Wilson "Comes Back"

Woodrow Wilson, former president of the United States, has come out of retirement and again is taking an active interest in political affairs.

Many think Wilson may again be a powerful figure in politics.

Wilson was president for two terms—eight years. He left the presidency in March, 1921, when Warren G. Harding, the president, took office.

As soon as he left office, Wilson went to his home at Washington. He seldom appeared in public. He remained quiet and obscure. He never wrote for publication.

Many tried to learn Wilson's opinions on the affairs of the nation. But he would give them no answer. Even when enemies criticized him, he remained silent.

Then—at a meeting of democratic party leaders in New York a message, thought to be from Wilson, was read. This message came from Joseph P. Tumulty, secretary to Wilson with president.

Shortly after this message had been read, Wilson sent a letter to New York newspaper denying that he had written or authorized the message.

Then a few days ago, Wilson wrote another letter—this time to a St. Louis newspaper.

This letter was about Senator James A. Reed of Missouri, who wants to be re-elected. Reed's friends had said that Reed had aided Wilson. But Wilson in his letter has denied aiding him in any way.

These two letters are Wilson's first public statements since he left the presidency. They indicate that his secluded days are over and that he probably will continue to take an active part in politics.

The glands in the neck may be slightly swollen. Or the disease may be like a very severe sore throat with large gray or white patches.

The cure lies in the question with whom antiseptics are administered.

Every case of scarlet fever is not always recognized. Some people have many cases of disease and never know it. Yet even a mild case is able to infect someone else with a very severe case.

Scarlet fever is an dangerous disease. It is not always recognized.

The disease is not in the blood, nor the rank of severity, but the damage is left in the complications which are very likely to follow in the wake of the disease.

The direct cause of the disease is not known. There is no specific antiseptic like vaccination. One contracted it must be cured, but it can also be avoided by taking that others do not come in contact with the sick person.

Children who escape scarlet fever until they are 10 years old seldom die of the disease.

Important symptoms of scarlet fever are bluish headache and vomiting. The disease develops on second day and the whole body is covered.

Hooping cough is a simple disease not found greatly by ignorant mothers who do not know the disease. It is a common disease among children.

Hooping cough is a serious and contagious disease. It is contracted by children coming in contact with others having it. An ignorant mother often lets her children play with others who have it, that the children may get it and have it to do with. This often amounts to murder.

The disease begins as an ordinary cold and cough, the distinctive symptom not appearing until a week or ten days later.

Whooping cough comes from the whooping sound it gives out.

It should not under any circumstances be allowed to associate with other children or return to school until permission from the doctor or health authorities has been obtained.

If a child becomes hoarse, faster, rapid breathing and constant cough, call a physician.

No. 3. Scarlet fever is a disease like scarlet fever that is not so serious in itself, but must be watched carefully because of possible results.

People are won over to it, just as to measles—if they don't have it themselves.

It usually affects children between 5 and 10, though adults may catch it.

Measles occurs especially in the month of early spring. Now it is the time to look out for it.

It is believed to be contracted by direct transmission from one person to another. One child has it twice.

The disease is seldom fatal, but it is painful and sometimes leaves permanent results.

One or two weeks before the disease develops fully the child will be drowsy and have a fever.

These symptoms will later be followed by a slight swelling under one of the ears which will gradually spread to the face.

Measles is chicken pox. The patient with measles requires much attention. Nevertheless, its symptoms are similar to those of other eruptive diseases, thus they may cause confusion and alarm.

Inasmuch as there is a possibility of confusing the disease with mild cases of smallpox, physician should be called in to look at the case in the beginning.

The disease usually begins with a slight fever, a feeling of uneasiness, aching in back and extremities and sometimes with vomiting. ## PROPERTY OWNER LIABLE IF TENANT IS A BOOTLEGGER

### Holder of Mortgage May Be Assessed, Also, Collector Says

The owner of property upon which illicit liquor is found may become liable for the internal revenue tax placed upon the contents of the property.

The owner of the property will be liable only, however, if it is proven that he knew liquor was being manufactured or sold upon his property by his tenants, in the opinion of B. C. Hernandez, collector in charge of the internal revenue office.

An opinion recently rendered in Colorado that the owner might become liable to pay all the tax imposed by the government upon bootleggers has caused a round of comment here by officers of the internal revenue department and the United States district attorney's office.

The district attorney's office and Mr. Hernandez are agreed that the old liquor dealer's license which the internal revenue office imposes upon bootleggers can become a lien against the property if the bootlegger is unable to pay.

The revenue collector, however, does not believe the property owner or holder of the mortgage can be held liable unless either are found to be aware of the liquor being sold on the property.

### A PUBLIC GOLF COURSE

FTER disposing of the water works expansion, the new sewer system and one or two other first essentials Albuquerque is sure to find itself in need of another public utility as a part of the enlarged and improved park system we are to have.

This is a public golf course. Every city in the country of the first population class has a number of such courses. Many of the smaller cities have provided them. Golf is no longer a game for the idle rich. It has been pointed out recently by an advocate of public courses that golf is the only amusement of Scotch derivation which may be enjoyed without violating our amended constitution. The popular demand for opportunity to play the game is growing almost as swiftly as radio. Almost anyone can have a radio receiving set in the house but mighty few of us control enough acreage to hold a golf course. The solution is the public golf course, which goes naturally with public parks and playgrounds.

"General" Coxey recently expressed concern lest the president's golf companions estrange him from the people. The "general" thus shows that he knows nothing about the president's golf game and proves that Coxey isn't close to the people, if he ever was. The president likes to play golf with enthusiastic golfers. One of his frequent companions at the game is a newspaper reporter. If Mr. Harding gets no further from intimate popular contact and sympathy than the golf course he will never be far out of touch. Golf has come to stay, not as a rich man's pastime, but as a popular sport that is already second to baseball in popular favor. In a few years the public golf course will be as much a part of matter-of-course municipal equipment as a school playground or a park.

### MUSCLE DOCTORS vs. DRUGS

ACCORDING to Walter Camp, for many years head of Yale's department of physical instruction and an acknowledged authority on sports, mental fitness is acquired by good physical condition. For many years that statement has been regarded among sportsmen and others who indulge in milder forms of exercise as exceedingly trite. Indeed, Walter Camp's conclusion will scarcely be attacked, even by those who grind out whole weeks and months and years without much attention to the physical machinery. Most men will agree, and women, too, that it would be perfectly fine to keep properly limbered up, to dance free in basketball games, track work, or with wall weights, but they cannot find the time. Their days are so filled that they dare not break away. Many of them, like the popular British novelist, have difficulty in living on 24 hours a day.

Unquestionably, physical recreation can be made a fetish. Men and women frequently become obsessed by it, even as other groups become fanatical as to vitamins and food values. Sift most of us down, and you usually find something lopsided, something that veers away from the middle-track, the entirely rational attitude toward life and its habits.

But the man or the woman who reserves some small portion of the day for exercise, even if it be no more than Walter Camp's "Daily Dozen" and a shower or a bath and the rub-down with a coarse cotton towel afterward, is the man or woman who consumes less medicine than those who neglect their bodies.

The man or woman who follows some regular exercise each morning and evening, whether in the bedroom or the gymnasium, is the man or the woman who keeps the most fit and vigorous, the one who is less inclined to fits of despondency—one of the natural concomitants of sluggish muscles and failure of the digestive and eliminative machinery properly to function.

It is the regularity of exercise that counts—not the most violent. It is the gradual, consistent upbuilding of the body that comes of the daily system of wing movements such as are outlined in Camp's prescriptions.

### A PRIMARY EXPERIENCE

ONCE more the Chicago Tribune, once advocate and insistent champion of the direct primary, comes forward to testify that its child of theory is a mighty poor citizen in mature activity in practical affairs.

The Illinois state primary for nomination of congressional, state and local officers is over. This is what the Tribune says about it:

The voters have had another experience with the direct primary law and they can ask themselves how much information they had for intelligent exercise of the duty the law places on

them. Probably the only people who knew exactly what was being done were the leaders and the short-sighted polities.

The politicians complicated the tickets to such an extent that the citizen whose main interest is not politics, and whose main interest should not be politics, might as well have been blindfolded when he went to the polls.

No one but the various group leaders knew what the candidates really stood for because no one but the group leaders knew what deals had been made and what promises were out. Here and there were names familiar to many voters, and some of them associated with good records of public service, but the great bulk of the tickets meant little to the average voter.

We do not believe it works. We do not believe that a citizen can be expected to equip himself with the information which will make him a well informed voter in such a primary election as that of yesterday. He will not do it even if he is expected to. If reputable organizations try to gather information as to the qualifications and affiliations of candidates such organizations are attacked and their motives questioned.

The purpose of the worst politicians is to create a general state of bewilderment and then drive into it with effective organization, getting their own results under the mask of popular decision. There is less responsibility in this than there is in a decently organized party convention in which the party leaders feel that they will be held accountable for bad nominations and will not be successful with them.

The theory of direct primaries may be all right. We were so convinced once, but experience has been an unpleasant teacher. We doubt that it would be possible for an electorate, however much given to political study, to sift out a great field of candidates for local offices and pick the good from the bad. Without such information the people are not protecting their government but are surrendering it to the shrewdest politicians operating with the greatest license.

We do not believe that ordered government comes out of disorder, and yesterday's primary was disorder.


