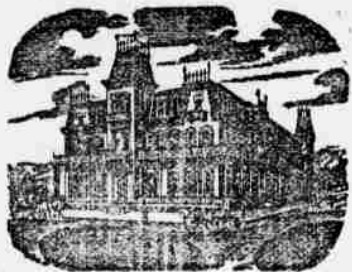

#### THE CATTLE QUARANTINE.

Governor Barber, of Wyoming, declines to Deal Fairly by the Southwest.

Denver, April 1.—A delegation of disappointed south-western stockmen reached here yesterday from Cheyenne, Wyo. They had been to ask Gov. Barber, of Wyoming, to withdraw his quarantine restrictions against New Mexico and Arizona cattle. This the governor declined to do.

The delegation was composed of D. E. Brooks and George L. Brooks, S. E. Booth, W. H. H. Llewellyn, of New Mexico; F. M. Town, J. V. Vickers, and Dr. A. J. Chandler, of Arizona; Dr. H. H. Halloway, of Montana; Dr. C. G. Lagab and J. L. Bruen, of Colorado.

"Our southern ranges," said one of this party, "are great for producing cattle, but not for maturing them. Experience has taught us that Montana beats the world in the latter respect. Consequently we ship there. It is necessary to drive from Oregon Junction, Wyo., which is situated on a branch of the Union Pacific, just on the edge of government land. We claim that the governor of that state has no authority to prevent the driving of our cattle across that ground. It is public property. It is as much ours as it is that of the citizens of that state. They have not preempted it and neither have we. It is public domain. But in order to have a show of legality, we claim to set up that our cattle are diseased. This is false. There are diseased cattle in Texas, as we all admit. But the quarantine laws of New Mexico and Arizona are even more strict than those of your state. There is no disease whatever among our stock. The whole trouble has originated with the Wyoming stockmen, who object to our cattle grazing as they pass through. They wish all the feed upon the government lands for their own herds. I think, however, everything will be satisfactorily arranged, as I am satisfied Gov. Barber will act fairly when he fully understands the situation."

**Bismarck's Birthday.**  
New York, April 1.—A dispatch from Berlin says: In scores of places throughout the fatherland the birthday of Prince Karl Otto Von Bismarck is being celebrated by his friends and adherents today. It was on April 1, 1833, that his arrival increased the population of the Duchy of Brandenburg, and consequently he is to day 59 years of age. Most of the celebrations to-day are under the auspices of the Universal German association, an organization of loyal sons of the fatherland who, although they do not often express it publicly, regard the ex-chancellor as being more worthy of loyalty and devotion than the reigning sovereign himself. Members of the many branches of this organization are observing the day as a public holiday, and the observance is on the whole much more widespread and hearty than those which succeeded his forced retirement to private life. The emperor, it is said, would very much have liked to prohibit these demonstrations, and there were rumors yesterday that the im-

### NEW ROADS FOR NEW MEXICO.

Significance of the Great Amount of Attention this Territory is Attracting Just Now.

In connection with the report that Jay Gould is about to buy the Pease Valley and extend it northwest from Eddy, via White Oaks, it is interesting to note what people and the newspapers are just now saying about New Mexico as a field for extensive railway building this year.

S. H. H. Clark, general manager of the Union Pacific system, has just made a trip through New Mexico, going as far as El Paso, where he conferred with Mr. Gould. Speaking of the latter, Mr. Clark says: "I would not say that his trip is exclusively for his health. Mr. Gould always has his eyes open on such occasions, and while he is recuperating his health, he is never losing a business opportunity. As to his purchase of the Pease Valley, I know nothing of it, but for all that, he may be contemplating such a move. While I have not investigated thoroughly with reference to the resources of the country, which the new line proposes to penetrate, I think that section about White Oaks is quite rich. Aside from the mineral wealth, however, I notice that the Texas & Pacific touches a section leading up to White Oaks which is capable of wonderful development as an agricultural district (the Pease valley). They have plenty of water, and I think they can make a great country of it."

Scott Morris brings the cheering information that Otto Mears has secured the money with which to build his road south from Durango, and will start work as soon as a right of way is granted through the Indian country, which will be done during the present session of congress. The road will come down the La Plata, pass through Farmington and Junction City and pass on through Gallegos canon. This is indeed welcome news.—Junction City Times.

Major Llewellyn tells the Denver Republican this respecting railroads in New Mexico: "I am inclined to think that when the Denver & El Paso and the Albuquerque & Durango companies begin building operations there will be railroad dirt flying all over New Mexico. The Santa Fe will not allow these people to do all the building. They will get into the White Oaks country with an extension from their main line, and also run over from Las Vegas east to the Texas Panhandle country; also from El Paso up to Eddy to open up the agricultural country. I understand the Denver & El Paso is backed and controlled by financially substantial men, and when they get to building a railroad into southern New Mexico they will stir up the Santa Fe to a desire to secure part of the benefits to be found in railway connections with the rich country both east and west of their main line and tributary to Albuquerque, Durango, Trinidad and Denver."

**Utah Republicans.**

The call of the roll by Secretary Harcel Platt developed an attendance of 400 delegates representing twenty-four counties. ## CITY REPUBLICANS.

A Strong Ticket Placed in the Field at the Convention Yesterday Afternoon—Names of the Winners.

**Earliest Resolutions Arranging the Democratic City Aldermen The Salary Grab De-nounced.**

The Republican city convention was called to order at the court house at 4 o'clock yesterday afternoon by Hon. L. A. Hughes, chairman of the city central committee. Besides the full delegation of twelve representatives, citizens from each of the four wards there were present a large number of citizens as on-lookers, who, while having no say in the proceedings, nevertheless showed their interest in good government by paying close attention to all that was said and done and joining heartily in the applause that frequently broke forth.

On motion of J. D. Sena, Jr., S. S. Beay was elected chairman, and on motion of C. M. Conklin J. D. Sena, Jr., was made secretary, R. G. Read, inter-pret.

The committee on credentials consisted of L. A. Hughes, A. L. Morrison and E. L. Bartlett, who reported all delegates present. Hon. Antonio Ortiz y Salazar, on motion of Judge Morrison, was made a delegate at large.

The committee on resolutions was named to consist of Aniceto Abeyta, S. Wesley, Antonio Ortiz y Salazar, E. L. Bartlett and A. L. Morrison.

While this committee was engaged in its duties the crowd was kept in a delighted mood by remarks of Judge Sena and B. M. Read.

The committee on resolutions reported the following which were adopted amid applause:

**THE RESOLUTIONS.**  
Whereas, The common council of the city of Santa Fe at a recent meeting passed an ordinance, the terms of which were that the mayor and city council should receive an annual salary of \$3.00 and that each alderman should receive the sum of \$5 for each regular meeting; and

Whereas, It was a well understood fact previous to the incorporation of a city that no compensation should be paid to any of said officers; therefore be it

Resolved, That the candidates of said city in convention assembled, that we demand said action of said city council as unwise, unparliamentary and as opposed to the best interests of our city and that we demand its prompt and unconditional repeal.

Resolved, That the candidates for mayor and aldermen to be placed on the Republican ticket be requested to use their best exertions in procuring the immediate repeal of said ordinance, and that they be requested to pledge themselves to oppose the passage of any such ordinance during their term of office.

Resolved, That we arraign the present city administration for its unbusinesslike method of procuring the city printing without advertising for bids, as required by law, and paying for the same more than the usual price of such work, without any attempt to reduce the price to the tax payers.

Resolved, That the action of the Democrats of the city of Santa Fe, in refusing to meet with the Republicans in the selection of a joint ticket, upon anything like fair or reasonable terms, has forced upon all good citizens and tax payers in said city the necessity for a republican ticket, which they should vote for and elect, as representing the best interests of a progressive and commercial city government.

Resolved, That it is the sense of this convention, that all expenses incurred for any purpose by the city government, should be kept within the lowest possible limit of taxation commensurate with the proper and adequate administration of its affairs.

**THE NOMINATIONS.**  
The convention then proceeded to the nomination of city officers and the unanimity with which the nominees were declared speaks admirably for success at the polls on Tuesday next.

On motion of A. L. Morrison, Manuel Valdez was nominated for mayor by acclamation.

On motion of Cosme Alarid, J. D. Hughes was unanimously named as his own successor for the city clerkship.

On motion J. B. Ortiz, S. Wesley was by acclamation chosen the nominee for city treasurer.

On motion of L. G. Read the following nominations made at ward meetings were unanimously ratified by the convention:

First Ward—For alderman, Juan Garcia, school directors, Geo. A. Johnson, J. Gonzales y Borrego.

Second Ward—For alderman—Eugenio Yriarri; school director, Juan J. Ortiz, E. H. Seward.

Third Ward—For alderman, T. B. Catron; school directors, John V. Conway, Marcos Castillo.

Fourth Ward—For alderman, R. J. Pallen; school directors, J. D. Sena, Jr., L. G. Read.

The convention listened to a stirring address by Hon. Aniceto Abeyta and adjourned amid cheers. Immediately a city campaign committee met and organized by electing Hon. L. A. Hughes chairman and J. D. Sena, Jr., as secretary.

**ROUND ABOUT TOWN.**

Arbor day is being enthusiastically observed in the capital city to-day.

A special freight train brought in eight car loads of merchandise over the narrow gauge yesterday.

Some of Santa Fe's merchants are getting a move on themselves and are doing there spring advertising already.

Manuel Valdez, the present efficient county assessor, will be the next mayor of Santa Fe. Already bids are being offered to this effect.

There are a great many unlicensed dogs running around the streets. "If the boys had been paid for the dogs that they caught this would not be so so," remarks one of the youngsters.

Harry Scranton, of Cerrillos, to-day bought J. W. Conway's ten-pin alley and will remove the same to the Little Pittsburgh for the edification of the horny handed miner when he needs a little real healthy exercise.

Yesterday afternoon at 4 o'clock the city council salary grabbers took it all back, and repealed the salary grab ordinance. Public sentiment was too strong for 'em. They were generally denounced for voting for the grab and had no other alternative but to try and undo their blunder. They will yet get paid dearly for their original ambitions in the premises.

The governor has received notice that a new postoffice has been established at Mesilla Park, Dona Ana county, with Wm. N. Hogan as postmaster. Also that Thomas J. Clark has been appointed postmaster at Gila, Grant county, and John Pendaries postmaster at Rociada, San Miguel county.

Santa Feans who are enjoying their usual sunshine to-day will be surprised to learn that a fearful snow and wind storm is raging at this writing in Kansas and Nebraska. All communication by wire has been cut off, is the message that reached the local telegraph office at 2 o'clock.

**THAT INTERNATIONAL AFFAIR.**

The Governor's Decision in the Case of the Accused Assassination Prisoners.

The governor has rendered his decision today in the extradition matter of the Assassination prisoners. The testimony taken at Las Cruces was very voluminous and the arguments of counsel covered many important points. The governor has notified the counsel that one week will be allowed for the service of notice of appeal before any mandate is issued, and that on receipt of notice of appeal all the papers will be forwarded to the secretary of state at Washington. The following is the decision as filed.

SANTA FE, N. M., April 1, 1902.

In the matter of the application of the Governor of the State of Chihuahua, in the republic of Mexico, for the extradition of Attila Isaac, Joaquin Jimenez and Severo Rubio.

After examining the papers and hearing counsel in this matter, I have concluded to grant the extradition in the cases of Joaquin Jimenez and Severo Rubio, and to decline to grant the same in the case of Attila Isaac.

## CLIFF DWELLERS CAPTURED.

A Remarkable Discovery in the San Mateo Mountains—The Captives on Exhibition Here To-day.

For the last few years a report has been in circulation that some diminutive people have from time to time been seen in various places in this territory in the neighborhood of the cliff dwellings that abound in the counties of Valencia and Bernalillo. Our readers will no doubt remember the account published last year relative to the finding of a couple of cliff dwellers in the immediate vicinity of San Mateo by Mr. Leonor Ansuarez, and the spirited chase which he reported and the losing of the tracts on account of a severe snow storm. A similar report came from the county of Grant about the same time. A great deal of fun was made of such reports at the time, and Mr. Ansuarez felt much hurt at the reports he read about his discovery, and ever since has been on the lookout for the people that he saw on that occasion. He has at last succeeded in finding and capturing a couple of the real and original dwellers of those abandoned cliff cities.

He arrived in the city this morning with his captives and will place them on exhibition this evening in the rooms of the Bureau of Immigration, in the old palace building, to give the people of Santa Fe an opportunity to see them before they are sent to Chicago, he having made arrangements to send them to a museum in that city. All persons wishing to see these interesting relics of the former inhabitants of the great southwest, may do so from 5 to 8 o'clock this evening. Mr. Ansuarez reports that one day last week, as he was herding his band of sheep at the same place where he made the discovery last year, he saw fresh tracks of what appeared three bare-footed children, and followed the same into the mountains, and about dark he came upon a sight that almost paralyzed him. He saw three human beings about the size of ordinary children of 10 years of age standing close to the entrance of an immense cave and he hid himself to watch developments and to see if it were possible to capture one of them. As he watched, the group sang a sweet and melancholy song, and entered the cave, and he immediately hastened to his camp and brought one of his companions with him and watched all night till about 5 in the morning, when two of the dwellers appeared, and they pounced upon and captured them and took them to the town of San Mateo, where they have been kept till brought to this city. To-morrow morning they will start for Chicago.
