SOMEBODY TOLD HEALY

Head of Stationary Firemen's

New York, Oct. 14.—The 400,000  
strong national committee, headed

## PREDICTS SUDDEN DEATH OF SHAH

Assassination Only Question of Short Time Declares Leader of Tabriz Insurrection.

The Morning Journal Special Leased Wire. Oct. 15.—That the Persian people will not have a constitution unless the present shah is killed and the national party becomes victorious is the opinion of an aged and venerable member of the Tabriz parliament named Mirza-Ali-Akbar, who is at present in this city for the purpose of establishing in the Turkish capital a permanent bureau of the revolutionary party in Persia. The Persians are sure in number and they will in the future direct the revolutionary operations in Persia from Constantinople. They have been driven out of Tabriz and forced to seek shelter on foreign soil.

"The government forces are getting the worst of it at Tabriz," continued Mirza-Ali-Akbar. "Our forces, the nationalists are gaining the upper hand and the projected capture of Tehran and the liquidation of the shah are only a question of time. I have full confidence in the future success of our revolutionary party. Our present aim is to win over the government forces to our side. The shah's soldiers are already discontented because they are not getting their money. Our men are loyal and well paid. We have at present over three thousand good fighters, together with six pieces of artillery and sufficient ammunition and provisions for some time to come.

"We have been almost uniformly successful in our recent operations and our men are bound in high spirits over the capture in Tabriz of sufficient quantities of arms and ammunition to equip an army of thirty thousand. This was material was in a government arsenal that fell into our hands."

**STANDARD WEIGHTS AND MEASURES ON HAND**

Scales Now Being Installed in Secretary's Office at Santa Fe Which Will be Standard for the Territory.

There are now being installed in the office of Secretary Nathan Davis at Santa Fe, scales and measures which will be the standard for New Mexico. The scales, which are the first to be had, arrived at the secretary's office yesterday, and were unpacked during the day. The scales will be installed on a concrete base and will be absolutely reliable and accurate. They are regulated by these standard units at headquarters, and will be used in the several counties of the territory.

Section 1. There is hereby created in each of the several counties of the territory of New Mexico, new scales or which may hereafter be created, the office of inspector of weights and measures.

Section 2. The board of county commissioners in each of the several counties of the territory of New Mexico, are hereby authorized and empowered to appoint in their respective counties an inspector of weights and measures. The first appointment under this act shall be made by the several boards of county commissioners immediately after the passage of this act and said officer so appointed shall hold his office for the term ending the first Monday in January 1909 or until his successor is duly appointed and qualified, unless sooner removed for cause by said board.

This secretary of the territory is hereby authorized and directed to purchase through the national bureau of standards as soon as possible after the passage of this act, a complete set of standards of weights and measures duly tested and certified to by said bureau, which set of standards shall be kept in the office of the secretary at the territorial capital.

There is hereby appropriated out of any funds in the territorial treasury, except of the interest fund, the sum of one hundred thousand dollars for the purchase of said set of standards, which shall be paid upon warrant drawn by the territorial auditor, supported by certified voucher of the secretary of the territory.

The board of county commissioners of each county in this territory, is hereby authorized and directed to purchase, as soon as possible after the passage of this act, through the national bureau of standards, a complete set of standards of weights and measures for such county, which set of standards shall conform to the standards of the territorial set of standards in the office of the secretary of the territory.

Section 2. It shall be the duty of the inspector of weights and measures, appointed under the provisions of the preceding section, before entering upon the discharge of his duties to take an oath as provided by law and furnish bond to the sum of one thousand dollars, signed by two or more good and sufficient sureties, or to some bonding company authorized to do business in the territory of New Mexico, to be approved by the board of county commissioners, and to be conditioned for the faithful discharge of his duties. After taking the oath of office and furnishing bond as herein provided, it shall be the duty of said inspector to take an oath as provided by law and furnish bond to the sum of one thousand dollars, signed by two or more good and sufficient sureties, or to some bonding company authorized to do business in the territory of New Mexico, to be approved by the board of county commissioners, and to be conditioned for the faithful discharge of his duties.

Section 3. It shall be the duty of the inspector of weights and measures, before entering upon the discharge of his duties, to take an oath as provided by law and furnish bond to the sum of one thousand dollars, signed by two or more good and sufficient sureties, or to some bonding company authorized to do business in the territory of New Mexico, to be approved by the board of county commissioners, and to be conditioned for the faithful discharge of his duties.

Section 4. The board of county commissioners of each county in this territory, is hereby authorized and directed to purchase, as soon as possible after the passage of this act, through the national bureau of standards, a complete set of standards of weights and measures for such county, which set of standards shall conform to the standards of the territorial set of standards in the office of the secretary of the territory.

Section 5. It shall be the duty of the inspector of weights and measures, before entering upon the discharge of his duties, to take an oath as provided by law and furnish bond to the sum of one thousand dollars, signed by two or more good and sufficient sureties, or to some bonding company authorized to do business in the territory of New Mexico, to be approved by the board of county commissioners, and to be conditioned for the faithful discharge of his duties.

Section 6. The board of county commissioners of each county in this territory, is hereby authorized and directed to purchase, as soon as possible after the passage of this act, through the national bureau of standards, a complete set of standards of weights and measures for such county, which set of standards shall conform to the standards of the territorial set of standards in the office of the secretary of the territory.

Section 7. It shall be the duty of the inspector of weights and measures, before entering upon the discharge of his duties, to take an oath as provided by law and furnish bond to the sum of one thousand dollars, signed by two or more good and sufficient sureties, or to some bonding company authorized to do business in the territory of New Mexico, to be approved by the board of county commissioners, and to be conditioned for the faithful discharge of his duties.

Section 8. The board of county commissioners of each county in this territory, is hereby authorized and directed to purchase, as soon as possible after the passage of this act, through the national bureau of standards, a complete set of standards of weights and measures for such county, which set of standards shall conform to the standards of the territorial set of standards in the office of the secretary of the territory.

knowingly sell, deliver, or attempt to sell or deliver, any short, false, or fraudulent weight or measure of any of the articles hereinbefore mentioned, shall be guilty of a misdemeanor, and upon conviction thereof shall be punished by a fine of not less than twenty-five (\$25.00) dollars nor more than one hundred (\$100.00) dollars, and upon second conviction for a like offense his license shall be revoked and he shall be prohibited in the same business or occupation for a period of one year thereafter.

Section 3. The salary of such inspector of weights and measures shall be one hundred (\$100.00) dollars per annum payable semi-annually out of the current expense fund of the county in which he is appointed, and he shall be allowed in addition to such salary the sum of fifty (\$50.00) dollars for traveling expenses for each trip of inspection, and he shall collect in the name of the territory from each person, partnership or corporation, the sum of fifty cents for each and every measure tested by him, and shall after each trip of inspection, make under oath a detailed statement of all such money so collected by him, which money shall be paid over by such inspector to the county treasurer of said county, and placed to the credit of the territorial expense fund, but he shall not be allowed to receive any compensation other than that herein provided, and the fifty (\$50.00) dollars traveling expenses for making each trip of inspection.

Section 4. Any person who sells or offers for sale any commodity whatsoever, by any false weight or measure, not corresponding with the weights and measures adopted by the United States government and in use by said government, shall be guilty of a misdemeanor, and upon conviction thereof shall be punished by a fine of not less than twenty-five (\$25.00) dollars nor more than one hundred (\$100.00) dollars, and upon second conviction for a like offense, his license under which he may be doing business shall be revoked, and no license shall be granted to such person to engage in the same business or occupation for a period of one year thereafter. Such person shall also forfeit to any person injured by the commission of such offense the sum of one hundred (\$100.00) dollars to be recovered in civil action, either before or after conviction.

Section 5. The office of inspector of weights and measures may be created in any incorporated city, town or village, under this act, by ordinance, and his duties, fees and emoluments shall conform to the provisions of this act. Whenever such office is so created by any municipality, the duties of the inspector of weights and measures appointed by the board of county commissioners shall be continued to the county of the county of the city, town or village creating such office by such ordinance.

Section 6. All acts and parts of acts in conflict herewith are hereby repealed, and this act shall take effect and be in force from and after the date of its passage.

# FINANCE AND COMMERCE

## Wall Street.

New York, Oct. 14.—The stock market took on all the aspects of a narrow professional affair today. Its varying fluctuations were very meaningless and reflected no convictions on the part of those responsible for the bulk of the dealings, but merely an attempt to affect a movement of price for trading purposes. The volume of the day's transactions was meager, and the constant shifting of the current of prices demonstrated the feeling of hesitation and uncertainty of those taking part in the market. Yesterday's disposition to favor to minor degree stocks as a medium for trading became more marked today, and was, in itself, an occasion for distrust. To add to the distrust felt toward the movement in trading, the demonstration of the lack of support for some of the stocks of a class only a little superior, which was marked yesterday. Sales of only a few blocks of these resulted in a collapse of the price. These evidences of the demonstration of the speculative movement prompted general selling which depressed prices. There was no actual reason to account for the depression. The call money market, however, continued to show a firmer tone and to suggest some coming curtailment of the abundance of funds for speculative uses, which has been the prime factor in keeping up prices. Some of the most influential of the clearing house banks were reported to be withdrawing some part of the loans they have extended for stock market use, and the professional traders were ready to infer that this presaged a changing attitude toward the stock market on the part of the powerful capitalistic groups affiliated with these banking institutions.
