THE DEALS OF CHINA'S NATIONAL TRAGEDY

Strange Mixture of Modern
Pomp and Barbarism Make
Up Dramatic Scenes in Im-
perial Death Chamber.

HUNDREDS WITNESSED
THE EMPRESS' DEATH

Indescribable Confusion Fol-
lowed Announcement of the
End; Baby Emperor Walls
Pitifully For His Old
Nurse.

Peking, Nov. 19.—An edict ordering posthumous honors for the late dowager empress was issued today and it enumerates for a fourth time since the death of his majesty the program of reforms to which the new regime is committed. These political edicts first began appearing four days ago, when, in the name of the emperor and the grand council, two edicts, one ordering the emperor to assume the reins of government and the other ordering the emperor to assume the reins of government, were published. One of these edicts after specifying a number of the reforms in question, says: "We have received recently the decree of the dowager empress appointing Pu Yi to be emperor. As this prince shows promise of being filial and intelligent, he can count upon the care and support of the dowager empress, and through his devotion to affairs of state he may bring tranquility to the empire. Officials must purify their hearts, abandon all abuses and heartily obey all reforms edicts."

With regard to the existing program of study have been given to its preparation. Its purpose is to establish a constitution for China at the end of nine years, and by completing what is left unfinished, you will comfort your spirit in heaven."

Another edict that was issued in the name of the late dowager empress, says:

"My attention has been given to a myriad of affairs and my strength and my heart are exhausted. Since last summer I have been ill and not able to assist in the multitudinous affairs of the government with tranquility. For long I have been unable to sleep. On November 14 came the death of the emperor and it was then I began this for me to exercise self-control. Following this day my illness increased until now I am not able to rise from my couch."

"I look back today over fifty years of sorrow and trouble and even at the end of my life my anxieties still are with me and I can find no respite."

"Reform in the method of government has begun in earnest. The empire the first in importance and to this end let him be adequately instructed."

These edicts, taken together, are considered to contain the basic reforms to be carried out in the new government.

Dalai Lama Arrives.
Prince Ching was present at the palace both yesterday and today. The forbidden city was crowded all day long with officials of various degrees and throngs of mourners and nobles in the gathering in the Dalai Lama of Tibet and all his disciples. Tomorrow morning at 10 o'clock there will be a service of Tibetan prayers for the repose of the late emperor's soul.

The Imperial Death Scene.
Accurate information concerning the last days of the emperor and the dowager empress was obtained today from officials of the palace. The various foreign legations in attempting to determine the cause of the death of the emperor and the dowager empress, have been ordered to refrain from making any statement. The symptoms of the emperor indicate that death resulted from nephritis and cardiac weakness, together with other complications.

The emperor made a speech less than one hour before his death. He passed away during a period of the greatest excitement and confusion. His native physicians had been hurriedly summoned to attend to him. They at once gave orders in accordance with the custom of the imperial family, observed for centuries past, that the emperor be dressed for death and the imperial yellow robe be spread over the road leading from the water palace to the forbidden city. At the same time the imperial physicians were made ready to attend the dowager empress to the death chamber.

The last illness of the dowager empress dated from November 1. On this day the court was terrified by an outbreak of uncontrolled temper from her majesty. On the 12th of November she suffered a paralytic stroke upon being informed of the serious condition of the emperor. On November 13 Prince Ching returned from his residence in the eastern hills, whither she had sent him to make a religious offering in the hope of pro-

phing the ghost that in her dreams had beckoned her to follow him out to the hills. An official of high standing said today that the empress had died of apoplexy and that she was able to talk and did talk up to a few hours of passing away. Both her majesties awaited the coming of the emperor in the death chamber. The emperor was surrounded by hundreds of court officials and followers. It was a barbarous exhibition of the soulless and inhuman formality and etiquette of the court. Soon after the deaths were announced hundreds of men, including everybody attached to the household departments, collected in the palace and remained there for three days.

The members of the grand council in a testamentary statement written expressly for her majesty have drawn a pitiful picture of her later sufferings. It mentions the agonizing feeling of an eye witness who stood astonished in the crowd at a protracted distance from the bedside of the dying woman.

On the night of November 16 the dowager empress called the members of the grand council together and talked with them for some time. She was lying prone, but fully conscious. After a short conversation the councilors were dismissed, but they were told to return at 2 o'clock in the morning with the edicts prepared to announce them.

It is reported that her majesty was able to signify her assent to these particular edicts but immediately after leaving down this she died.

"I can hear no more," and relapsed into unconsciousness.

Emperor Follows Death.
The emperor and dowager empress were laid out in the death chamber when the reforms were issued.

As soon as it was actually known throughout the palace that their majesties were dead a condition of panic ensued. Many of the palace eunuchs attempted to commit suicide because they perceived they would not be made dowager empress. There was an outbreak of weeping and a general pandemonium. Many of the palace eunuchs fled, carrying with them such valuables as they could lay their hands on. The dowager empress Yeholien was one of the few who remained in the palace. She ordered that the gates be guarded and gave other instructions for the maintenance and restoration of order.

Today the eunuchs have returned and the palace has been cleared and except for the continuance of the funeral obsequies and observances, conditions at the palace are normal. The principal consorts of the late Emperor Pu Yi, the baby emperor, have been taken from his family and cared for within the palace precincts.

He is popularly reported as crying day and night for his old nurse.

Tokio Confident of Peace.
Tokio, Nov. 20.—Absolute confidence is expressed in all government circles that under the normal conditions in China and that normal conditions will soon be resumed.

Japanese Confidence Restored.
Tokio, Nov. 20.—Stocks on the Tokyo exchange have rebounded almost to their original figures and bonds are advancing.

FORGERIES MAY BE TWO MILLIONS
Van Vliessen Committed 458 Separate Crimes and 100 People Are Likely to Be Losers.

Instead of twenty-five about one hundred persons will be losers. The exact number of outstanding forgeries is 458. It is said that the rushing of Van Vliessen to the penitentiary earlier in the day was to get him there before the full extent of his forgeries became known.

LOSES CONTROL OF BANK HE SAVED
Former Controller of Currency Ridgely Evades Out of National Bank of Kansas City.

Kansas City, Nov. 19.—At the close of business today William E. Ridgely, president of the National Bank of Kansas City, and Edward Ridgely, cashier, presented their resignations to the board of directors of the National Bank of Kansas City and they were accepted.

Dr. W. S. Woods, the ex-president of the bank and his associates, immediately assumed control, having recently gained control of a majority of the stock of the business. James T. Bradley, of Sedan, Kan., was elected cashier.

William E. Ridgely resigned the controlship of the bank, but is said to be in the hands of a receiver. He was recently successful and the bank had \$1,250,000 in deposits.

Recent transfers of stock have caused the Ridgelys to lose control.

Optimism Snuggled into Manila.
Manila, Nov. 20.—Edmondson, an extensive plot to smuggle opium here from China have been discovered. A fortnight ago workmen employed on the military buildings at Camp Steno were discovered a quantity of opium concealed in the cement which had been shipped from Hong Kong. Workmen engaged yesterday on the building of the new barracks at Camp Steno and found it to be half filled with opium. The opium has been turned over to the customs officials and the government is now investigating.

WILL DEMANDS FREE TRADE WITH CANADA
New York, Nov. 19.—In a distinctly new world atmosphere, the 40th annual banquet of the New York chamber of commerce was held tonight in the Waldorf-Astoria. Gilbert Stuart's famous portrait of Washington, flanked on either side by portraits of President Diaz of Mexico and President Roosevelt, was the principal feature of the dinner and the principal formal address dealt with the United States and her two near neighbors on the North American continent.

The guests of honor were the British ambassador, James Bryce, Joseph P. Gurney, Mexican charge d'affaires at Washington, E. W. Glasscock, and Clifford Sifton, both of Canada, and J. J. Hill, the railroad builder of the Northwest.

Calling attention to the close connection between the two countries, United States and Canada, J. J. Hill showed the importance of the trade between the two countries and scored what he called the policy of mutual exclusion.

"What the commercial relations ought to be," he said, "is indicated by their parallel development and the mingling of their commerce. Without consulting any lawyers here, I don't hesitate to declare my own opinion. I believe that the most natural, the most rational, the most highly profitable commercial state between Canada and the United States is absolute freedom of trade."

"That commerce must eventually move unobstructed between these two peoples is self-evident. Why not strike off the shackles now and let it move freely instead of paying the heavy penalty of delay? Protection has no meaning or effect as applied by either one of these countries against the other. The assumption of some fixed variations in the wage level is nonsense. Men are free to come and go, and New England at this moment depends for her labor largely upon her French-Canadian population. Wages do vary, just as they vary between New York and Colorado, but their average under similar conditions is the same in the two countries."

WARM DEFENSE OF GOMPERS ACTION

POLITICAL ACTIVITY
CAUSES HOT DEBATE

Denver Convention of American Federation of Labor Discusses Leaders' Part in the Late National Campaign.

(By Morning Journal Special Leased Wire)

Denver, Nov. 19.—The annual convention of the American Federation of Labor today was given over to the consideration of the report of the committee on the president's report. Two sections entered a prolonged debate, and a vote was reached on only one, that referring to "litigation harassing labor." The report of the committee recommending that injunctions be disregarded was defeated on roll call 11,272 to 2,576, and a modification of the report along the lines of Gompers' report was adopted.

The rest of the session was taken up discussing the election of the president of the federation.

This section criticized Daniel J. Keefe for not acting with the rest of the executive committee.

It has been announced that the Journeymen Barbers' union has decided to begin the fight for shorter hours.

Will Go To Jail.

John Mitchell at the afternoon session offered a second amendment to the committee's report, saying in part: "Within a few days the committee will decide whether the president, secretary and myself shall go to jail. I don't want to go to jail. But I shall accept that judgment and I shall go to jail." This amendment was brought forward from the delegates.

Mr. Mitchell's amendment was to insert certain words so that the report should read, with the amendments of Delegate Duncan and himself as follows:

"Whenever the courts issue an injunction to regulate our personal relations we declare we will exercise all the rights and privileges guaranteed by the constitution and laws of the country and insist that it is our duty to defend ourselves at all hazards and to defend ourselves in all cases, taking whatever results may follow."

Several other delegates discussed the amendments and Representative Farnsworth closed the discussion with a defense of the committee's report.

The motion of Mr. Duncan's resolution and that of Mr. Mitchell were voted on together. A roll call was demanded to settle the entire question. The amendment was adopted by a vote of 11,272 to 2,576.

The next section of the president's report referred to the political action of Mr. Gompers, and the executive council during the late presidential campaign. Under the caption "Political action and political action," the report described the actions of the president and executive council during this time.

The committee quoted three resolutions from the report which it officially commends.

The first was:

"The American labor movement is not partisan to a political party; it is partisan to a principle of equal rights and human freedom."

The second was:

"Our conventions have declared that our movement has not the right to be divided into two camps, one for the privilege of being in the right, and one for the privilege of being in the wrong. I have not departed and am not now departing from that true trade union course. At the Minneapolis convention the following declaration was adopted:

"We must have with us in our movement as well as all others, and the minority right of the humiliated and oppressed. We have no place in a movement where his conscience dictates must be sacrificed."

The committee in its report on the question says:

"We hold that this does not hold in the case of an executive officer, while he remains as such. If he is unable to agree with this and must oppose it, he should resign. If he is unable to resign, he should be removed from office. This recommendation was aimed directly at Daniel J. Keefe, who as a member of the executive council in support of W. H. Taft for president after the council had declared in favor of W. J. Bryan.

The third quotation is the closing words of Mr. Gompers on the political campaign, in which he says:

"It has been my purpose to place before you the entire matter in connection with my participation in the campaign, whatever consequences it may entail. I submit to you for such judgment as you may see fit to render and this action as you may see fit to take. I am deeply conscious of one fact, that I have endeavored to give voice to the strong feeling which labor has, and which the laborers are entitled to have, in regard to the fighting of these wars. I have pressed home to the fullest the suffering and the hardship which follows. To the very limit of my ability, and power, I have done so. I have thrown it into the scale for the cause of my fellow workers."

Max Hayes, of the Transportation union, objected to the report of the committee and argued that the federation wanted to go into politics. It would be better for it to support the socialist party in preference to the democratic.

Several other delegates spoke in opposition to the committee's report, but a vote was not reached when the convention adjourned until tomorrow morning.
