## NEWS FROM TAMPA.

The Four Squadrons of "Rough Riders"

Anxious for Active Service.

The New Mexican's Tampa, Fla., correspondent states, that there are nearly 600 men of the "Rough Riders" still in camp there, namely the four troops that did not go to Cuba and about 150 recruits, 100 of who hail from New Mexico. The squadron is well drilled and in excellent shape and will compare favorably with the regular cavalry. Major Hersey, who is in command, has worked hard and faithfully to bring the squadron to a high state of efficiency and Captain George Curry, commanding Troop H, is proving a very valuable and good officer. The division commander, General J. J. Coppinger, has congratulated Major Hersey upon the fine state of discipline and efficiency that prevails among the "Rough Riders." The officers and men are anxious for active service and want to go either to Cuba or Puerto Rico to get at the Spaniards. It is believed that they will be sent to Cuba soon to join the eight troops there under Colonel Roosevelt and that the entire regiment will be sent to Puerto Rico. However, no orders to that effect had been received yesterday afternoon from Major Hersey's states. The major informs the New Mexican that he has made strenuous efforts to be sent to active service in the field and Governor Otero has telegraphed the War department, asking that Major Hersey and Troops G and I, composed principally of New Mexico volunteers be put into the field, either in Cuba or Puerto Rico. The command is in good shape and splendid fighting trim, there is no sickness, but the officers and men, from Major Hersey down, are tired of Tampa and camp duty and are very anxious for active campaigning.

Letter from Sergeant Armijo.

District Clerk A. M. Bergere has received a letter from his nephew, George W. Armijo, son of Mrs. Lola Luna, of Albuquerque. Young Armijo is a sergeant of Troop F, Captain Max. Luna's company in the "Rough Riders," now in Cuba, and it has been reported so much in letters and through dispatches, that Sergeant Armijo had his hand shot off at the engagement of La Quasina, that his friends have generally believed the report. Mr. Bergere's letter brings the welcome news that the wound was not near so serious as has been thought. The injury, writes the young man, is simply a flesh wound in the left hand and no bones were broken. Sergeant Armijo is now at the hospital at Fort McPherson, Ga. His hand has about healed and he expects to soon join his company again. The letter speaks very highly of the bravery of the young captain and all the members of the company engaged in the fight, wherein Armijo was wounded.

Court Notes.

A transcript of the record in the case of Josephine Deserant, administratrix, vs. the Cerrillos Coal Railway Company, has been certified to the Territorial Supreme court by Clerk Bergere. R. E. Twitchell appears as attorney for the railway company and F. W. Clancy and N. B. Field for the plaintiff.

In the District court for San Juan county, in the case of Rafael Martin vs. Antonio Sandoval et al., involving the question of water rights, A. M. Bergere has been appointed a referee to take testimony. He will set a date for that purpose some time soon.

It is understood that the Territorial Supreme court will appoint a new clerk, when it assembles next week; also that Mr. Wylls will tender his resignation on the assembling of the court. There are several candidates for the position, the leading ones being Mr. A. M. Bergere, clerk of the District court here, and Hon. J. D. Sena, who well and ably represented this county in the lower house of the 32nd legislative assembly.

The docket of the Territorial Supreme court for the coming session is the largest in many years. Colonel R. E. Twitchell alone has seven cases on the docket.
