TWO INDICTMENTS ARE DISMISSED

By Prosecution in Coal Land Fraud Cases

WERE RECENTLY FOUND

Charged Conspiracy to De- fraud and Were Against New Jersey Parties.

According to adjournment the U. S. district court for the First Judicial District, met at 2 o'clock this afternoon, Judge John R. McFie presiding. The U. S. grand jury which has been in session since the 26th instant was called into court and on motion of Special Assistant Attorney General Ormsby McHarg it was dismissed from further attendance and discharged. No indictments were returned and no report of its deliberations made, although it is understood that exhaustive investigations were made into the reports and rumors of alleged fixing or attempted bribery of jurors during recent sessions of the court and of the grand jury.

Assistant U. S. Attorney David J. Leahy then moved for the admission to the practice of law in this district of Hon. Henry M. Hoyt, solicitor general of the United States, which motion was granted by the court, and the name of Solicitor General Hoyt was also noted as counsel for the United States in the prosecution of the indictments for conspiracy to defraud the United States out of certain coal lands found a month ago against a number of officials connected with Phelps-Dodge and Company and others.

Upon the motion of Ormsby McHarg, special assistant attorney general, indictments for conspiracy to defraud the United States out of certain coal lands in San Juan county returned by the grand jury a month ago against Miss Henrietta G. Ricketts and Maggie A. Vann, of Trenton, New Jersey, were dismissed and the defendants in these two cases were allowed to go without day.

The dismissal of the Ricketts and Vann indictments by the United States is no criterion as to what action is to be taken in the remainder of the coal land cases. The decision in the Ricketts and Vann cases was arrived at after careful investigation into the circumstances connected with them alone. Miss Vann is the colored servant in the Ricketts family.

The September term of the U. S. court for this district then adjourned sine die.

In open court here this afternoon Captain David J. Leahy was formally sworn in as U. S. district attorney for New Mexico. The oath was administered by Clerk Francis C. Wilson of the First Judicial district.

SURE PRESIDENT WILL NOT RUN

David S. Jordan, Close Friend of
Roosevelt's Says Renomination is
Out of Question.

Chicago, Nov. 29.—David Starret Jordan, president of Leland Stanford University and a life long friend of President Roosevelt, declared here last night that Roosevelt will not be a candidate for renomination.

"Of course no one can speak officially for the President," said Jordan, "but I have no hesitation in saying absolutely and as emphatically as possible that he will not again be a candidate."

TWINS BORN ON THANKSGIVING DAY

Mrs. J. Napoleone Presents Husband
With Two Boys—One Dies Four
Hours After Birth.

Twin boys were born yesterday to Mr. and Mrs. J. Napoleone at their home on Manhattan avenue. One of the babies lived only four hours but the other is still alive and it is believed will survive. The mother is doing nicely.

THEATRICAL MANAGERS LOSE IN KANSAS CITY.

Kansas City, Nov. 29.—Judge Smith McPherson in the United States circuit court here today dissolved the injunction recently granted local theatrical managers prohibiting the county officials from closing the local theaters on Sundays. He said the court had no jurisdiction. Judge Wallace of the criminal court is now free to order the county officers to raid the theaters on Sunday.

OKLAHOMANS ARE ALWAYS BOOSTING

Ex-Governor L. Bradford Prince Talks
Interestingly of His Recent Visit
to Muskogee.

A representative of the New Mexican took advantage of the holiday yesterday to have an interview with Hon. L. Bradford Prince, relative to his recent experiences in Oklahoma. "It is a very interesting thing," said the ex-governor, "to be present at the birth of a new state; especially for us who have so long hoped for similar good fortune. The president signed the proclamation on Saturday and the Trans-Mississippi Congress opened on Tuesday morning; so that we were practically present at the opening of the new era. Many officers were still vacant as appointments were not yet made, but the confusion from this and the financial depression, had no effect on the spirits of the people. They were all buoyant, confident and full of faith in the future. Everyone was rejoicing and a cheer was on every tongue. The feeling of joy that at last they had self-government and the certainty that great improvement and prosperity would immediately follow, were universal."

"The governor, both senators and many leading men were present and made speeches. The senators certainly present a picturesque appearance, one being partly of Choctaw blood and the other totally blind. Both are eloquent speakers and will quickly make their mark in Washington; the Indian is very forcible in his manner and I should think was a man of strong passions, but kept well under control. I happened to see a good deal of them and both expressed their happiness that there would be two new votes in the Senate and eight in the House to aid New Mexico to statehood. They will be strong fighters for our rights."

"Muskogee is a most extraordinary city and yet they say it is not different from Guthrie and Oklahoma City. I wish every New Mexican could be there for a day to see the marvelous spirit of energy, enterprise and 'push' that prevails there. Then we would have 200 active citizens at the Board of Trade meeting in Santa Fe tonight, instead of a dozen."

"I have never seen anything approaching it east or west. Every one is full of public spirit and is using all his time and strength to push the city to the front. A little while ago it had but 4,000 inhabitants, now it has 24,000; and they have a remarkable organization called the '100,000 Club,' which is determined to bring the population up to that figure in two or three years. They have headquarters for residents from each of the states largely represented, like Kansas, Missouri, Arkansas, Texas, Iowa, Illinois and no visitor from any of those states can escape the hearty welcome of his own people and a glowing account of the advantages of Muskogee. If he does not buy a few lots and conclude to settle down, it is a miracle."

"The people, through pure enterprise and without much wealth, have built fine business blocks, banks, churches, hotels and have every modern improvement imaginable. An example of their wonderful energy is shown in the erection of one of the finest and largest auditorium in the West, for the meeting of the Congress. They raised \$60,000 in cash among the citizens and put up the entire structure, ready for use, in four months. If we could import about three of their active men we would have the long needed theater open for Christmas. Nearly every man on the streets wears a large badge, reading: 'I live here, ask me;' and they are only too glad to answer. Really it was an inspiration to see what can be done by a moderate number of live men, all working together for success."

PISTOL DUEL IN STREETS OF OAKLAND

Three Are Wounded, One Fatally, in
Fight Between Officers and Chinamen in California City.

Oakland, Calif., Nov. 29.—A pistol duel between Deputy Sheriff Pitt and a special policeman on one side and a Chinaman and four white men on the other, took place in a park at Sixth and Allice streets last night in which fifty shots were fired.

Special Policeman D. G. Murdock, W. H. Ryan, a non-combatant, and Wong Lee, a Chinaman, were wounded. Lee will die.

The white men engaged in the fight are believed to have been imported from San Jose by one faction of Chinese to take a hand in a war which has been in progress here several days during which several Chinese have been killed or injured.

COLORADO MINING TOWN HAS DISASTROUS FIRE.

Leadville, Colo., Nov. 29.—A fire which started from the overturning of a lamp in a barber shop late last night destroyed three-fourths of the town of Granite, a small mining town twenty miles east of Leadville. The total loss is estimated at \$25,000.

LAST WEEK OF BRADLEY TRIAL

Case Will be Given To Jury Monday

DEFENDANT AGAIN RECALLED

Denied She Ever Threatened to Shoot Senator Brown ---Defense Rests

Washington, Nov. 29.—Mrs. Bradley's trial was resumed this morning. District Attorney Baker submitted to the court the government's prayers in the case, saying they did not cover crimes of murder in the first or second degree, that point being left for the instruction of the court.

Rev. David H. Utter, pastor of the Unitarian church of Denver, formerly of Salt Lake, who performed the marriage ceremony between Mr. and Mrs. Bradley, testified that during a conversation with Mrs. Bradley he expressed to her his belief that Brown would not marry her. He urged her to give up her idea of marrying Brown. She replied:

"When it comes to a test and a gun is pointed at him, Brown will accede."

Defendant Made Threats.

At a later conference Dr. Utter said Mrs. Bradley declared she would force Brown to marry her. She did not say she would shoot Brown herself and the witness got the impression that her father or somebody else would do Brown bodily harm. Mrs. Bradley's reputation for peace, and good order, he testified, was good. After leaving the stand Dr. Utter sat beside Mrs. Bradley and they talked freely.

Experts Assert She Was Sane.

Dr. Edward S. Brush, a government expert, declared that in his opinion when Mrs. Bradley shot Senator Brown she was perfectly sane. Mrs. Bradley's case, he said, presented no symptoms of puerperal insanity nor any symptoms of general infection that had been testified to.

Dr. Smith Jelliffe testified that Mrs. Bradley had neither puerperal nor toxic insanity when she shot Brown.

Mrs. Bradley Recalled.

Mrs. Bradley was recalled to the stand this afternoon. She said she had no recollection of the details of a conversation with Dr. Utter as related by him. The defense then rested. Justice Stafford announced that the arguments would begin tomorrow and that the case would then go to the jury not later than Monday of next week.

PARALYSIS CLAIMS SOUTHERN STATESMAN

General Leon Jastremsk, Democratic
Candidate for Governor, Dies at
Baton Rouge.

Baton Rouge, La., Nov. 29.—General Leon Jastremsk, Confederate veteran, candidate for the Democratic nomination for governor of Louisiana, and formerly grand chancellor of the Knights of Pythias of the United States, died at his home here this morning. He was stricken with paralysis a week ago at the height of his campaign.

Jastremsk was one of the most prominent makers of the gulf state's history. He was a native of France and 64 years old. When once formerly a candidate for governor he was defeated on a platform embodying the reforms on which all the candidates for governor are making their fight in the present campaign.

Jastremsk rose from a private to captain in the Confederate army.

POWERS TRIAL BEGUN AT LAST

Jury Which is to Try Former State
Official For Murder is Non-
Partisan.

Georgetown, Ky., Nov. 29.—The state began today the introduction of testimony in the trial of Caleb Powers, charged with the murder of William Goebel. Counsel for the defense announced that the defense would admit that the fatal bullet was fired from the window of Powers' office when he was secretary of state. The jury consists of four Republicans, four Democrats and four Independents.

AGED CHICAGO JURIST DIES AT ADVANCED AGE.

Chicago, Nov. 29.—Former Judge James B. Bradwell, one of Chicago's most distinguished pioneers, died today at the residence of his daughter, Mrs. F. A. Helmer, in this city. Until two weeks ago Bradwell continued to take an active part in the management of the Chicago Legal News of which he was the publisher.

MADE ASSISTANT ATTORNEY GENERAL

Major Llewellyn Receives Merited Promotion

COMMISSION IS MAILED

Capt. Leahy To Assume Du- ties of District Attorney At Once.

Special to the New Mexican.

Washington, Nov. 29.—The commission of Captain David J. Leahy as United States attorney for the district of New Mexico, vice Major W. H. H. Llewellyn, resigned, was mailed yesterday to Captain Leahy from the Department of Justice in this city to Captain Leahy's official residence at Las Vegas, New Mexico, and will reach him Sunday or Monday. Captain Leahy is to qualify at once and take charge of the duties of the office.

The commission of Major W. H. H. Llewellyn of Las Cruces, New Mexico, who recently resigned from the office of United States attorney for the district of New Mexico, and who was appointed assistant attorney general upon his resignation as United States attorney for New Mexico, was mailed yesterday from the Department of Justice to Major Llewellyn, addressed to his official residence at Las Cruces, and will reach him Sunday or Monday. The new assistant attorney general will be in charge of special and important work under instructions of the attorney general at Washington.

MURDERER MUST DIE ON GALLOWES

Nebraska Man Convicted of Atrocious
Crime, Sentenced to Hang By
Judge.

Beatrice, Neb., Nov. 29.—Judge Kelliger today sentenced R. Meade Shumway convicted of the murder of Mrs. Jacob Martin, to be hanged March 13. The crime for which Shumway was convicted was one of the most atrocious ever perpetrated in this part of the state. Mrs. Martin was the wife of Shumway's employer, who was left alone with the man while her husband was at a primary election. The husband discovered the mutilated body of his wife on his return to the farm. Shumway was missing, together with about \$200 in cash. A chase lasting a week, failed to secure the capture of the accused murderer, but after all hope of capturing him had been abandoned, he was finally caught in Missouri. Lynching was threatened at several different times after the return of Shumway by the officers to Nebraska, but actual violence was not attempted.

BRYAN UNVEILS MARBLE FOUNTAIN

Simple Gift to Perpetuate Memory of
Wealthy Man Given to New Eng-
land City.

New York, Nov. 29.—A marble fountain, bearing the simple inscription: "Phillie Sherman Bennett gave this to the city," and erected on the green very close to the old town pump, a town landmark, was dedicated today and handed over to the custody of the city. The gift was provided for in the will of Mr. Bennett, whose will was administered by William Jennings Bryan, a close friend. Bryan presented the fountain to the city during the exercises on the green. Mayor John D. Studler received the gift on behalf of the city. Bryan will deliver four addresses during his stay here, the last being at a banquet in his honor tonight.

MEXICO'S FOREMOST MUSICIAN DEAD

Pneumonia Claims Ricardo Castro,
Who Won International Fame as
Pianist and Composer.

City of Mexico, Nov. 29.—Ricardo Castro, Mexico's foremost musician, died here yesterday of pneumonia. He was not yet 30 years old but had achieved international fame as a pianist and composer. He was director general of the National Conservatory of Music in this city.

SECRETARY TAIT'S MOTHER SLOWLY SINKING AWAY.

Millbury, Mass., Nov. 29.—Mrs. Louisa Tait, mother of Secretary of War William H. Taft, is falling every day, according to a statement made by a member of her household today.

SECURES LIBERTY ON THANKSGIVING

A. C. Miera is Granted Pardon By Gov-
ernor Curry—Has Been a Model
Prisoner.

Following the custom of granting a pardon to some deserving inmate of the territorial penitentiary on Thanksgiving day which has been found to have an excellent moral effect, Governor Curry yesterday issued a pardon to A. C. Miera, who was serving a ten years sentence from Union county.

Miera had served three years of his sentence and during that period proved a model prisoner. He had been a trusty for some time and was allowed considerable freedom, driving to and from the city after the mail and "running errands."

Miera's pardon was recommended by the prison officials, together with practically all of the county officials of Union county all but one of the members of the 27th legislative assembly, and many prominent men throughout New Mexico.

Five other inmates were also discharged yesterday at the expiration of their sentences. They were Martin Gonzales y Blea, Eugenio Orona, Augustin Lucero, Mauricio Chavez and Major Toney. The latter is a colored man.

Martin Gonzales y Blea was the oldest inmate of the prison, being about 55 years of age. He served a twenty-five year sentence, minus the allowance for good behavior, which began in 1894.

SENATORIAL POSSIBILITIES

El Paso Herald Believes Judge Fall
and Governor Curry Would Make
Good Team.

The El Paso Herald of yesterday evening contains a very readable story running under a three column head entitled, "A. B. Fall Slated For Senator from New Mexico When a State."

The article gives Judge Fall's remarkable career as a "miner." It also describes Judge Fall's career in politics and his profession of law in the territory, brings out Colonel W. C. Greene as a probable United States senator from Arizona and Governor George Curry as another United States senator from New Mexico. The Herald does not give the source of its information.

THANKSGIVING DAY AT PENITENTIARY

Superintendent Green Gives Inmates
Great Spread—Minstrel Show
Feature of Observance.

Thanksgiving day this year will be one long to be remembered by the inmates of the territorial penitentiary. Superintendent John W. Green treated his charges to a big turkey dinner at noon. Two hundred pounds of turkey were required to go around and all had enough to eat and to spare. Besides generous allowance of roast turkey the bill of fare included cranberry sauce, mince pies, mashed potatoes and other delicacies.

A feature of the observance was a minstrel show in the afternoon which was witnessed by a number of citizens as well as the inmates of the prison.

SPEEDING TRAIN HITS TROLLEY

Five Killed in Rail- road Crossing Accident

VICTIMS HORRIBLY MANGLED

Flagman and Conductor of Electric Car Arrested For Negligence.

Waterbury, Conn., Nov. 29.—Five factory employees were killed today at the West Main street crossing over the highland division tracks of the New York, New Haven and Hartford railroad when an extra freight train crashed into a trolley car containing twenty-five passengers bound for the pin factories in Oakville.

The car was struck with great force directly in the middle and all the passengers killed were badly mangled.

Six others were badly injured. Flagman John Flavin and Conductor John Dillon of the trolley car were arrested.

ACCIDENT STOPS FOOTBALL GAME

Indian Player Sus- tains Broken Leg

MISHAP IN FIRST HALF

Superintendent Crandall May Place Football Un- der Ban Hereafter.

The Thanksgiving football game between eleven of the Santa Fe High School and the U. S. Indian School of this city which had been looked forward to with keen interest by local enthusiasts, ended abruptly yesterday when one of the players met with an accident which resulted in a broken leg. The mishap occurred within a few minutes after the initial kick off and before the teams had a chance to get fairly warmed up for the fray or the comparative strength of the combating teams could be gauged.

Few of the spectators along the sidelines or in the grandstand saw the accident or knew anybody was hurt until one of the players was discerned lying prone on the ground after a scrimmage. Jose Martinez, a Papago Indian, who was playing half back on the Indian eleven, was the unfortunate youth. In falling to the ground he twisted his left leg in such a way that it was fractured. It was a clean break between the ankle and the knee and the bottom part hung only by the flesh and skin.

Dr. David Knapp who was witnessing the game from the side lines was summoned on the gridiron when it was realized that the Indian boy was seriously injured and he pronounced the limb as broken when he examined it. The unfortunate lad was placed in a carriage and conveyed to the Indian School hospital, where the fractured limb was set later by Dr. W. S. Harroun, the regular physician and surgeon of the institution.

Stopped the Game.

Superintendent Clinton J. Crandall of the U. S. Indian School, who was among the first to reach the side of the victim, when he saw how badly the boy was hurt ordered the game stopped for fear of another accident. Mr. Crandall stated today that he was thinking seriously of having football tabooed at the institution in the future as it is such dangerous sport.

Six hundred people turned out to witness yesterday's game which promised to be an exciting contest as both teams were apparently evenly matched. Few cared to see the contest proceed, however, after the accident happened. Instead of returning the money paid for admission as was at first announced it was suggested that the gate receipts amounting to about \$25, be turned over to the Woman's Board of Trade, to which all acquiesced willingly.

Elevens Evenly Matched.

The Indians started the game by kicking off, having elected to defend the east goal. The ball was sent spinning far down the field but it alighted in the arms of a high school player who plunged forward the instant he clutched the pigskin and darted in the opposite direction. He returned the oval over thirty yards before he was downed. Then followed a few scrimmages in which the ball changed hands several times on downs or fouls, and when the mishap occurred that brought the game to a sudden termination the two teams were in the center of the gridiron.

A similar but not as serious an accident happened a few days ago in a scrimmage practice on the campus at St. Michael's college. One of the players in being tackled sustained the fracture of one of the small bones of the foot, but the injury did not prevent him from being on hand to witness yesterday's game between the high school and Indian school teams.

SURPLUS OF CURRENCY SAYS VANDERLIP

New York Banker Predicts Payments
Will Be Resumed in Near Future—
Censures Interior Banks.

Chicago, Nov. 29.—Frank W. Vanderlip, vice-president of the City National Bank of New York, while visiting here yesterday, predicted that the currency situation will get back to normal conditions as soon as the December pay rolls are met.

"There is entirely an adequate supply of currency at the present time," he said. "The interior banks are undoubtedly hoarding money; that is they are running their reserves up to an abnormal point."

CONSIDER THE SOURCE.

The New Mexican's Albuquerque morning contemporary likes to hear itself talk and to pose as the mentor and law giver not only of the Republicans of New Mexico, but also of its people. The pose and the manner adopted by the sheet attract only humorous attention, no more and no less. Its blatherskite editorials are often so laughable and based on such dense ignorance, selfish hypocrisy and hypocritical selfishness that it would be a waste of time to discuss them seriously. Once in a while it becomes necessary to do so simply to remind the people of the windy, flimsy, untruthful, and libelous methods the paper uses in its warfare on the Republican party of New Mexico, on Republican principles, on leaders of the party, on its rank and file, and on Republican officials generally. For instance, the paper claims that U. S. District Attorney W. H. H. Llewellyn has been removed from office because it demanded it and fought the official. The fact is that Major Llewellyn has voluntarily resigned as district attorney for New Mexico and has been promoted to assistant attorney general of the United States; he has in his possession a letter written to him but a few days ago by high authority, expressing full confidence in District Attorney Llewellyn's integrity and clean conduct as well as ability and efficiency as an official, and assuring Major Llewellyn of continued friendship and esteem.

The New Mexican's Albuquerque morning contemporary in a number of issues, especially during the past twelve months, has intimated, insinuated and at times called the president of the United States a fool who was easily duped and imposed upon by a corrupt gang in New Mexico and has charged the president with having committed a "crime against civilization" and with having sounded the death knell and brought about the ruin of the Republican party in New Mexico.

In its issue of Wednesday of this week it bitterly and vehemently assails Chairman H. O. Bursum of the Republican Territorial Central Committee and what is more the bone and sinew of the Republican party and prominent men in this territory. According to this editorial the leaders and prominent men as well as the members of the Republican organization in this territory are held in leash and controlled by the lash in the hands of Chairman Bursum. There are hundreds of prominent Republicans, who, according to that sheet, dare not say that their souls are their own and that although they are neither office holders as are the men who control the editorial utterances of the Journal and want no offices, are accused of being dire cowards and bowing to the will and dictation of one man. There is as much to that charge as there is to the story that the moon is made of green cheese.

In the same editorial the sheet endeavors to cover Attorney General Albert B. Fall with fulsome flattery in order to draw a comparison between the action of the attorney general in resigning his office and the action of Chairman Bursum in remaining in the high and honorable position to which he was elected by the unanimous sentiment of a truly representative and loyal Republican convention. The comparison is not odious. It is simply too foolish and too crazy to be earnestly considered.

In the same editorial the sheet threatens sure defeat for the Republican party next year should Mr. Bursum remain as chairman and should Delegate Andrews be re-nominated to represent the people of this territory in Congress. The Journal represents the voters of New Mexico about as much as Abdul Hamid, sultan of Turkey, represents the incumbent of St. Peter's chair at Rome. The presumption of the sheet can not be seriously considered. It can only be laughed at and that is what happens.

In the meantime the population of New Mexico is steadily increasing, more capital than ever is coming in, despite the recent financial flurries, business is good, material and educational conditions are steadily improving, and the Republican party of the territory, regardless of the political humbugs and fake reformers in the Duke City, is growing steadily in influence and in strength.

LET THE PEOPLE SPEAK!

It is to be hoped that tomorrow's meeting of representative citizens in this city to consider ways and means for pushing the statehood agitation and to select a delegation to go to the national capital to work for statehood, will be well attended. Governor Curry will lay before the convention conditions as he found them in Washington and will make a report that will convince those in attendance that the chances for obtaining the passage of an enabling act for New Mexico during the first three months of the coming session are very bright and encouraging.

Of course very little can and will be done until after the holiday recess of Congress and it looks as if the right time for the delegates to repair to the nation's capital will be about the middle of January. The right thing at the right time would be the selection of Governor Curry as chairman of the delegation. This should consist as nearly as can be apportioned of leading and representative citizens, about half and half to be taken from each great political party in the territory. The delegates should be chosen especially because their hearts are in the movement and because they will work for the cause, earnestly, sincerely and loyally.

A delegation say of twenty or more of this class of citizens will also benefit this territory in other ways, as their presence, their behavior, their conduct and their appearance in Washington will demonstrate that New Mexico possesses citizens of whom any commonwealth may well be proud.

Referring to the statehood question and tomorrow's meeting the Albuquerque Citizen voices the sentiment of the people in the following editorial:

"It is very encouraging to know that the president has renewed his promise to aid this territory in its fight for statehood and that he has told our governor that he will do all he can to that end. Governor Curry upon his return from St. Louis, where he met the president said that the president had promised us assistance. Now upon his return from Washington he says that the president repeated that promise upon the eve of the convening Congress. The governor also saw a large number of congressmen and has received such encouragement that he does not hesitate to say that the chances of this territory's admission to the union are the best in her history. A territorial statehood meeting has been called to assemble in Santa Fe, November 30, for the purpose of selecting representative men to go to Washington and aid in securing the passage of a statehood bill, which will be introduced by Delegate Andrews shortly after Congress convenes. People all over New Mexico are so universally in favor of statehood that they have grown to take statehood meetings as a matter of course. It is very important, however, that the meeting at Santa Fe on November 30th be largely attended and that every one who can possibly do so, should take an active part in the selection of the men who will visit Washington. There are no politics in the meeting. It is a citizens' gathering, for the purpose above named and no other. Governor Curry expects to return to Washington just as soon as possible and he needs the help of every New Mexican. The governor desires all the influence that it is possible to secure for the purpose of bringing the statehood question squarely before congress in the right light. Those who know the governor believe that he, if any one, can secure statehood for this territory and it is up to every one to co-operate. Bernalillo county should send a large delegation of her best citizens, and Hon. W. B. Childers, the president of our local statehood league, should call that organization together promptly in order to make the necessary arrangements. The Bernalillo County Statehood League is composed of good substantial business men and citizens of this county and they ought by all means to lead in the fight for statehood. It is a duty to ourselves, the territory and our governor."

A BUREAU OF MINES NEEDED.

The agitation for the creation of a bureau of mining is moving along and it looks as if the subject would be considered by the 60th Congress and that probably favorably. It is stated on good authority that the president's forthcoming message will contain a recommendation for the establishing of such a bureau and this will bring the matter to the direct attention of the Congress. Referring to it the St. Louis Globe-Democrat editorially says: "The annual meeting of the American Mining Congress has just been held at Joplin, Missouri, the center of the greatest zinc mining district in the world. One of the delegates made the announcement on the strength of a recent interview in the White House, that the President's message, shortly to be submitted to Congress, will include a recommendation that a government bureau of mines be established. From time to time government reports have set forth the great expansion in the mining industries of the United States. All the old forms of mining are growing fast, and extensive new ones are added to the list frequently, the general increase each year amounting to many millions.

"Reports on mining at present come from the United States geological survey, which is conducted under the direction of the interior department. According to the official figures published at the end of last year the value of the metallic and non-metallic mineral products of this country increased from \$364,000,000 in 1880 to \$1,623,000,000 in 1905, a greater rate of growth than has occurred in any other form of American industry. Within twenty-five years this country has taken the lead in coal, iron, copper and other articles. It produced in 1905 \$41,000,000 of natural gas, \$149,000,000 of clay products, \$35,000,000 of cement, \$63,000,000 of stone, \$10,000,000 of lime, \$6,000,000 of salt, and the other items are on a like scale. Our gold production in 1906 was \$94,000,000 and silver \$38,000,000. These two products combined exceed the yield of treasure in the Rand district. A distinctive bureau of mines at Washington would deal with a large subject, and one of the most important in a nationally economic sense."

THE SHOE FITS THE OTHER FOOT.

Harper's Weekly in a recent issue "jumped astraddle" the Las Vegas bankers editorially because the banks of the Meadow City issued clearing house certificates which courageously and honestly stated upon their face that payment would be made when the clearing house committee deemed advisable. This was done not for the purpose of deceit or to be dishonest, but simply to give those who received the clearing house certificates due and timely notice of the purpose and intention of the banks that issued them. Like many other newspapers and many many men that great "journal of civilization" saw the splinter in the eye of the Las Vegas clearing house association but paid no attention to the great big beams in the eyes of the clearing house association and banks in its own great city. The Pueblo Chieftain neatly turns the tables on Harper's Weekly editorially remarking:

"The current number of Harper's Weekly contains an editorial 'roast' of the clearing house certificates issued in Las Vegas, New Mexico. In view of the fact that the financial difficulties of the west were wholly due to the suspension of payment by the New York banks, and the issue by these banks of clearing house certificates and other forms of 'Johnsmith' currency—as it is now called—it would seem that the Weekly might have found a target for its ammunition nearer home. The New York writer seems to find special objection to the statement that the Las Vegas certificates will be paid when the clearing house committee thinks it is advisable but the only fault with this seems to be that the New Mexicans have boldly and honorably stated upon the face of these certificates the fact relating to their payment, which fact the New York financiers have tried to conceal and misrepresent."

It may be that the selection of the city wherein the Republican national convention for the nomination of candidates for the presidency and vice-presidency is to be held will be decided by the vote of the national committee from New Mexico, namely: Hon. Solomon Luna, of Los Lunas. It is understood that the sentiment of the members of the committee is evenly divided, and that the vote from New Mexico may be the deciding factor. This has happened once already in recent years and it may be the case this time. The deciding vote of Mr. Luna took the convention in 1904 to Chicago, where the winning candidates were nominated. The deciding vote of Mr. Luna may take it to Kansas City this time where, judging by the signs of the times and conditions, the winning ticket will be nominated.

Governor Haskell of the new state of Oklahoma is determined to keep the new commonwealth before the people of the country at large. He is making a good deal of noise. He evidently believes that a new broom sweeps clean.

On return of the delegation from

FINE MOUNTAIN SCENERY VALUABLE

One of Switzerland's Chief Sources of
Revenue—Pride of California and
Other States.

The American Forestry Association
under the heading of Press Bulletin
No. 20, points out the great value of
mountain scenery to a section of coun-
try wherein mountains are located. It
cites Switzerland and California as
glowing examples of beautiful moun-
tain ranges.

Switzerland has for one of its chief
sources of income the tourists who go
to see the wonderful scenery. That
country has greatly increased the fa-
cilities of travel by building roads
throughout the mountains. Much
might be done by American mountain
communities in this way. At Harpers
Ferry, for instance, which is an im-
portant resort, the roads are very dif-
ficult and lead people to abstain from
mountain drives who would be glad
to take them. It would pay to build
roads and to conserve the forests
where these affect the scenery. One
of the Yearbooks of the Department
of Agriculture has a striking illus-
trated article on mountain roads as
a source of revenue.

The White Mountains, as is well
known, are the Switzerland of Amer-
ica. Thousands of tourists go to that
region every year to enjoy the beau-
tiful scenery. A California writer says
that the wide-famed charm of Califor-
nia in the winter does not surpass
and scarcely equals, the charm of New
England in the summer. Yet this love-
ly region is being devastated by the
destruction of forests. This magazine
and other publications have already
told how beauty is being replaced by
ugliness, where landslides have oc-
curred and where verdant regions
have been converted into charcoal
and wooden skeletons.

Much of beauty still remains. It

days for Trinidad.

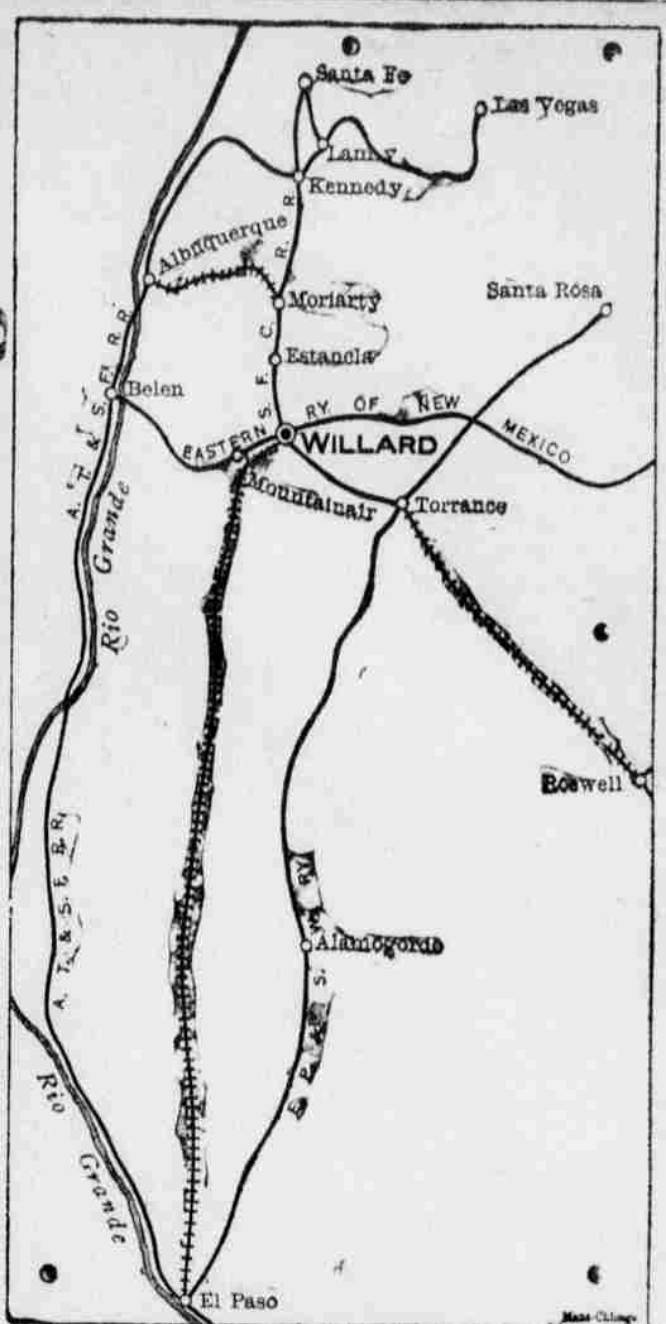

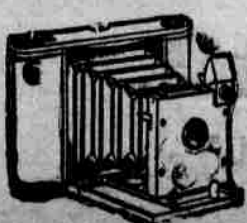

The New Mexican's Daily Short Story

Love's Volapuk.

(Original.)

How did I court my wife, she not understanding English nor I German? I will tell you.

My father was born in a town in Germany. He came to America, where he married my mother, but he died before I had learned to talk. Consequently I never heard his tongue spoken in the family. When I was twenty-five my mother suggested that I go to his native country and make the acquaintance of some of my relatives there. So I crossed the water and visited his native town.

In this way I made up my own bouquet.

I was in no hurry to transact my business and leave the shop. Indeed, I wished to chat with the fraulein. I wished to tell her that I was from America, but since to speak or write the information would avail nothing I took out my pencil and on a bit of wrapping paper drew a map of North and South America, marked off the United States and put in my state and city. She understood perfectly, smiled and extended her arms as if surrounding some invisible large article. This I knew meant that I came from a great country, and when she opened a cash drawer and made a motion similar to the first I mentally added, "And Americans are all rich."

Just when I began to speak love's language I don't know, but I remember very soon pointing to a rose and then to her cheek. Then I pointed to the ripples in the basin of the fountain on which the sun shone through a window, put my fingers on my hair and looked at her own wavy tresses. She blushed, and I moved my fingers to my lips, still pointing at the shining water, meaning that the same smile described her smile. This was not so plain, but she understood, and, as Tom Moore puts it, the smile came.

Like any fair lake which the breeze is upon When it breaks into dimples and laughs in the sun.

You see, I got on swimmingly. I spent an hour in the store talking this sort of thing, waiting when a customer came in till he went out again, and finally, feeling that I couldn't possibly make an excuse to stay any longer, I took my card, wrote the name and address of my aunt, to whom I wished the flowers sent, and made signs which meant that both were to go immediately. When the girl took up the card I saw a surprised look on her face, but she didn't say anything.

In the afternoon I received a note written in very bad English saying that my aunt and cousins would be pleased to see me in the evening. I found them in a house that had once been a fine one, but badly out of repair. It had been in the family for two centuries. I was not surprised, for I knew that they had lost their money at the time my father emigrated to America. My aunt received me cordially, and what was my surprise to see standing behind her in a corner, blushing and smiling, the flower girl. My aunt led her out from her retreat, saying to me:

"Cousin."

Well, you could have knocked me down with a feather. I blushed myself like a schoolboy. If it hadn't been for having met her before and all the truck I'd been giving her in my sign language I'd have gone up to her and given her a cousinly smack. As it was, I stood looking at her like a fool.

My aunt, who spoke a few words of English, acted as interpreter. And such interpretation! I had fallen in love with my cousin in the shop at first sight and could have talked with her in the universal tongue as fast as a forty horsepower automobile can go, but with her mother between us we didn't get on at all. The old lady was feeble and soon retired, offering to call in a friend who spoke English very well to keep things going between us cousins. I declined, telling her that I'd rather sit and say nothing than put any one to such trouble. She went out, saying that she was glad to find her nephew such a "lebbhafter" young man, or something that sounded like it, and I replied, "A regular blitzen, isn't he?" Then the old lady went upstairs and left us alone together.

My cousin found a German-English dictionary, which we used for awhile to talk about ordinary things, but I soon drifted into "spoons" and found the book entirely inadequate to the purpose. Flinging it down, I took up the sign language again—my eyes were a complete dictionary in themselves—and I found lovemaking as easy as tobogganing, only faster. Before we parted I had settled everything. This is the way I did it. I put my arm around her waist and slipped my seal ring on her finger. Then, taking out my handkerchief, I held it up and fanned it, representing a shirt and waist by

the wind. By all this she knew that I loved her and wished her to be my wife and go with me across the sea to America. Couldn't have been plainer, could it?

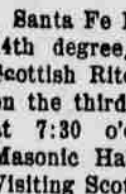

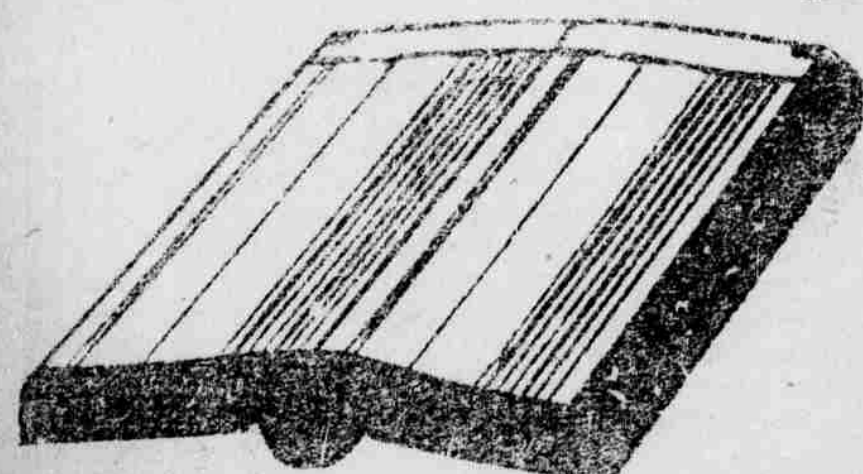

FOOTBALL CHAMPIONS OF THE SOUTHWEST.



The College of Agriculture and Mechanic Arts Football Team, Which Yesterday Defeated the New Mexico Military Institute Eleven at El Paso by the Overwhelming Score of 28 to 0.

FARMERS WALLOPED CADETS AT EL PASO

Agricultural College Eleven Found Roswell Team Easy—Final Score 28 to 0.

El Paso, Tex., Nov. 29.—The husky "Farmers" from the Agricultural college at Mesilla Park put it all over the Soldier boys from the Military Institute here yesterday for the football championship of New Mexico, winning the game by a score of 28 to 0. The farmers made a safety and a touchdown in the first half, failing to kick goal.

In the second half, during the first ten minutes of play, the Mesilla park team scored a touchdown and kicked a goal. They then carried the ball down the field and scored on a forward pass. Another touchdown followed, with no goal, and in the last two minutes of play the farmers kicked a goal from the field.

The Roswell team was much lighter than the Agricultural College boys, and had no chance at any stage of the game, although they put up a plucky contest. The farmers celebrated last night at the Orpheum theater.

TEXAS FUGITIVE IS ARRESTED AT ALBUQUERQUE.

Albuquerque, N. M., Nov. 29.—William Shears, alias William Blackie, regarded as a desperate criminal, and wanted in Texas for a murder said to have been committed a year ago, was arrested in this city last night by Officer George Highbargin. Mounted Policeman Murray, who has been on Shears' trail for months and who furnished Highbargin with a description of the man, was notified last night.

Shears, with two other men, whose names were not learned, came down from the Domingo lumber camp, where they have been working, yesterday, spending Thanksgiving in the city. They had intended going to the Black mountains near Magdalena last night on a hunting trip, and when arrested Shears and his companions were walking towards the depot, where they had left their guns, tents and other equipment.

FELTON NEW HEAD OF MEXICAN CENTRAL

Resigns Presidency of Chicago and Alton to Take Position—Road in Harriman Hands.

El Paso, Tex., Nov. 29.—It is stated at the offices of the Mexican Central Railway here that S. M. Felton, president and director of the Chicago and Alton railroad, has been elected president of the Mexican Central Railway at a salary of \$50,000 a year. It also indicates clearly that E. H. Harriman has become a dominating factor in the affairs of the Mexican Central.

Mr. Felton passed through the city in his private car a week ago en route east from a trip over the lines of the Central. He is expected to assume charge of the Mexican Central early in the coming month. His headquarters will be in Mexico City, although he will probably spend much of his time in New York.

President Felton succeeds Eben Richards, who is also general counsel of the Mexican Central. Richards has held the position of acting president of the road since A. A. Robinson resigned two years ago.

The present mileage of the Mexican Central is 3,156 miles. It is stated that negotiations for a consolidation of the Mexican Central with other lines will be resumed at an early date.

PEACE OFFICER HELD TO THE GRAND JURY.

Albuquerque, N. M., Nov. 29.—Zacarias Padilla, justice of the peace of San Rafael, Valencia county, who was brought to Albuquerque Tuesday charged with violating a federal statute, and after an exciting experience with some of his fellow citizens at San Rafael, who allege that he bound them over to the grand jury as justice of the peace, after assailing them as a private citizen, was arraigned before United States Commissioner H. R. Whiting in Old Albuquerque, waived examination and was bound over to the grand jury in the sum of \$500 bail which was promptly furnished. Padilla's father, Manuel Padilla y Chavez, a wealthy and influential citizen of San Rafael, came to Albuquerque and appeared in court with his son, whom, he alleges, is the victim of some very determined enemies. Attorneys Chaves and Sedillo appear for Padilla.

FOUR AMERICANS SLAIN BY YAQUIS

Report Reaches El Paso of Another Indian Outrage in Northwestern Mexico.

El Paso, Tex., Nov. 29.—Members of a prospecting party who have been in the state of Sonora, Mexico, bring a story of butchery by Yaqui Indians in which four persons were killed and two injured when the Indians raided a pack train of twenty-seven burros and scattered provisions in the train over a distance of several miles.

The Americans in the prospecting party were unarmed because Mexican laws do not allow them to take any arms into the country. Out in the desert at Monton de Lena, they met two badly frightened Mexicans who told of a Yaqui raid that had just occurred a few miles ahead. Investigation found the badly mutilated bodies of four men and the horribly wounded form of another.

The Indians have made five raids in that immediate vicinity in the last seven days and other deaths are reported.

CLAIMS FOOTPAD BROKE HIS LEG

Henry Bramstedt of Albuquerque, Found Early This Morning on Delgado Street.

After lying on the ground from midnight until early this morning with his left leg broken between the ankle and knee, Henry Bramstedt, of Albuquerque, was found by a passerby, and later was removed to St. Vincent's hospital, where the fracture was reduced by Dr. J. A. Massie. The injured man claims to have been the victim of a holdup last night, the footpad having either kicked him in the shin with a heavy soled shoe, and struck him over the limb with a club. In the darkness he says he could not tell, and he sank helpless in the street.

According to Bramstedt's story he was on his way to his room last night and being a stranger in town he became lost. He met a man much larger than he who offered to direct him to a lodging house and suspecting nothing he followed. He noticed that they were in the outskirts of the city and informed his chance acquaintance of this fact, when suddenly he felt something strike his leg and he fell injured to the ground. He said his assailant then beat him with his fist and after going through his pockets left him lying helpless in the street. He says he called for help at intervals during the night but his appeals were unanswered until day began breaking.

Chief of Police J. H. McHughes was notified early this morning that a man with a broken leg was lying in the roadway on Delgado street and went to the place designated in a carriage. He found the injured man there benumbed with cold and conveyed him to the hospital.

BEAUTIFUL AUTUMN WEATHER CONTINUES

Fair Tonight and Saturday With Stationary Temperature—Twenty-three Degrees Today.

Santa Fe's autumn weather this year is almost as superb as the climate that obtains during the summer months, for which it is noted far and wide. The mornings and evenings are crisp, cool and invigorating, and it is mild in the bright sunshine.

The temperature at 6 o'clock this morning was 23 degrees which was also the lowest during last night. The relative humidity at 6 a. m. was 74 per cent and at 6 p. m. 51 or an average for the day of 62 per cent.

Wednesday's maximum temperature was 52 degrees and the minimum temperature 25 degrees while the average relative humidity was 54 per cent.

Today's official weather forecast for New Mexico is fair weather tonight and Saturday with stationary temperature.

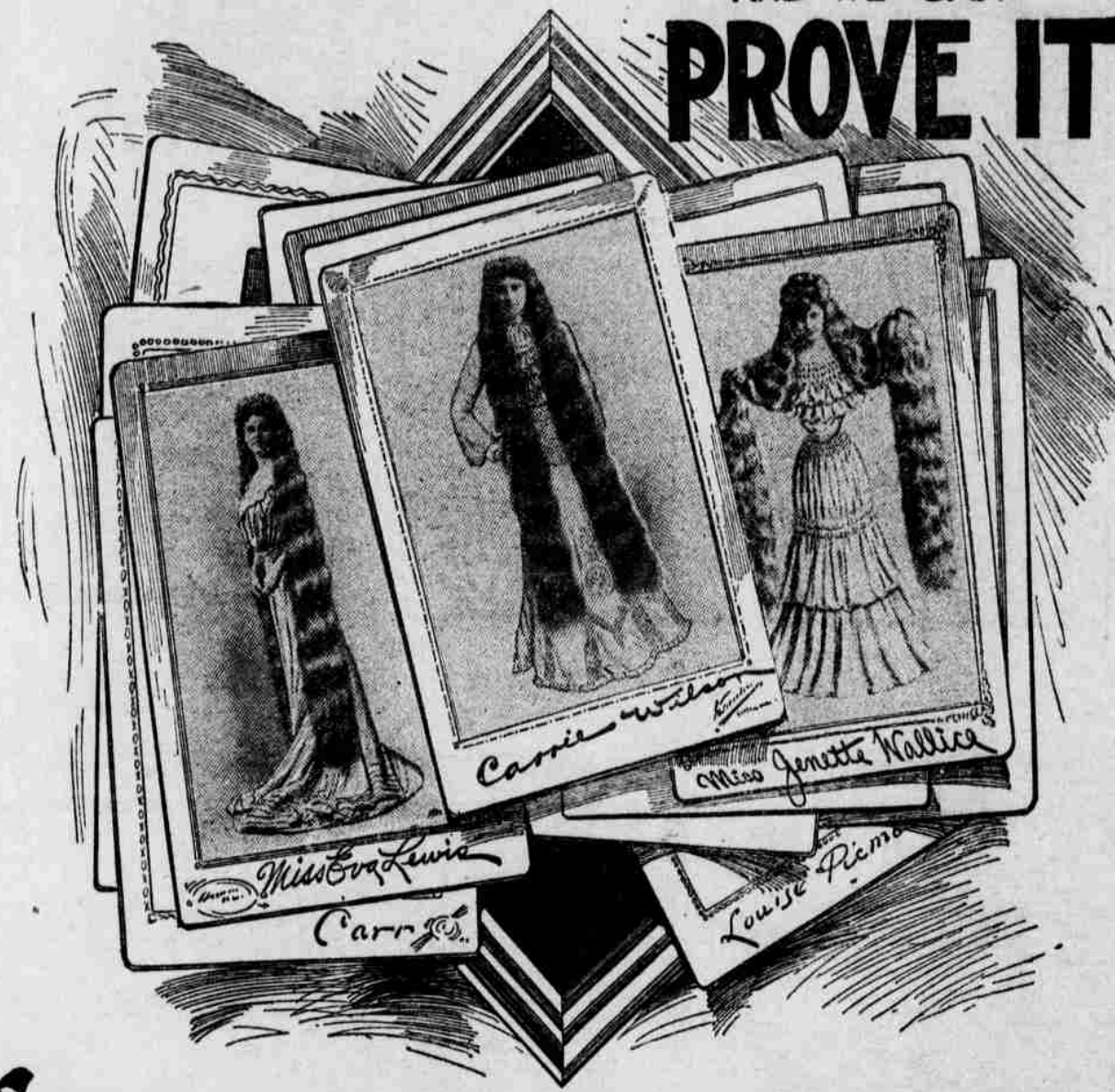
FIRE ALMOST WIPES OUT WYOMING TOWN.

CRUSHED UNDER WHEELS OF TRAIN

C. M. Moriarty, Son of M. T. Moriarty, Dies at McAlester, Oklahoma—Body Buried Here.

Funeral services were held yesterday over the remains of C. M. Moriarty of Haleyville, Oklahoma, a son of Mr. and Mrs. M. T. Moriarty, of Moriarty. Requiem mass was solemnized at the Guadalupe church by the pastor, Rev. Adrian Rabeyrolle, after which the body was buried in the parish cemetery.

The deceased died at McAlester, Oklahoma, on November 19, as the result of a railroad accident there, while he was on his way to Muskogee, Oklahoma. He attempted to board a train while it was in motion and was thrown beneath the wheels, one of his legs being crushed and other injuries being sustained. He was removed to the All Saints' hospital in that city, where he expired early the following day. The bursting of an artery is ascribed as the immediate cause of death.

M. T. Moriarty, of Moriarty, the father of the unfortunate young man, went to McAlester immediately upon being apprised of his son's death, and accompanied the remains to this city.

The deceased had been working as a railroad switchman at Haleyville, but was not employed at the time of the fatal accident. He was married but had no children. His widow is a present in McAlester, where she went to settle her husband's estate. She will later remove to Moriarty to make her home with her husband's parents.
